Summary of Actions, Works in Progress, Concerns for next year:

Actions

- Reaffirmed decision to “mirror” the Tampa, Sarasota, Lakeland, & Health general education requirements.
- Provided for a general education information session to all faculty on December 7, 2007. (Presenters were Dr. Gladis Kersaint, Chair – Tampa, Sarasota, Lakeland, & Health General Education Council and Dr. Janet Moore, Associate Dean of Undergraduate Studies, USF Tampa.)

- Distributed lists of approved general education courses to all faculty who teach in affected disciplines.
- Negotiated the process for the Tampa, Sarasota, Lakeland, & Health General Education Council to consider new USFSP general education courses for approved use in Tampa, Sarasota, Lakeland, & Health general education requirements.
- Developed a process for USFSP submission of new general education courses.
- Worked with a faculty member on the first USFSP course proposal.
- Provided a USFSP liaison who attended the USF Tampa, Sarasota, Lakeland, & Health General Education Council meetings in Tampa.

Works in Progress

- Providing continued education and support of faculty who will be implementing the new general education requirements
- Providing continued education and support of faculty who propose new USFSP general education courses.
- Providing a clearly defined structure for assessment of general education courses and program.
- Providing a clearly defined structure for review of on-going general education courses.

Concerns

- Absence of funding to implement innovative classroom methods at USFSP for new course proposals.
- Absence of funding to replicate the Tampa, Sarasota, Lakeland, & Health General Education Council proposed course mentoring systems on courses already approved by this committee.
- Need to meet with VCAA to discuss priorities and direction.
