A SENATE STATUTORY AMENDMENT

Be it enacted by the Senate of the University of South Florida Student Government assembled, that the following changes be made to the Student Government Statutes:

Chapter

305

Executive Branch Structure

305.1 The fifty-second term Executive Branch shall be composed as outlined below. Individual positions outlined below shall be contingent upon position funding in accordance with Chapters 307 and 807 respectively.

305.1.2 The Executive Branch shall include the following Departments:

305.1.2.1 Department of Marketing -- shall oversee and coordinate the production of all Student Government marketing materials as well as implement all marketing initiatives.

305.1.2.1.1 The department shall be comprised of the following positions: a Director, two Associate Directors and four Coordinators.

305.1.2.3 Department of University and Community Affairs -- shall serve as the principal advocate and counsel on all matters pertaining to issues of the University Community and scholarly merit.

305.1.2.3.1 The department shall be comprised of the following positions: a Director and two Associate Directors.

305.1.2.4 Department of Government Affairs – shall serve as the principal advocate and counsel on all matters pertaining to any private or public entities foreign to the University of South Florida.

305.1.2.4.1 The department shall be comprised of the following positions: a Director and an Associate Director.

305.1.2.5 Student Life and Traditions – shall execute and manage all programs, initiatives, and traditions of Student Government.


305.1.2.5.1 The department shall be comprised of the following positions: a Director, an Associate Director and two coordinators.

305.1.3 The Executive Branch shall include the following deputy positions:

305.1.3.1 Deputy Chief of Staff – shall aid the Chief of Staff in their duties and carry out all necessary and proper tasks delegate to them by the Chief of Staff.


305.1.3.2 Deputy Attorney General – shall aid the Attorney General in their duties and carry out all necessary and proper tasks delegated to them by the Attorney General.

305.1.3.3 Deputy Chief Financial Officer – shall aid the Chief Financial Officer in their duties and carry out all necessary and proper tasks as delegated to them by the Chief Financial Officer.
