Dean Fueyo and Dr. Zafer Unal opened the meeting, and the faculty approved the meeting agenda.

Miscellaneous Business

The Wellness Center provided an announcement of services and distributed a brochure listing the opportunities for participating in its offerings.

NCATE Continuous Improvement

Dean Fueyo presented an overview of the NCATE Continuous Improvement process and asked the faculty to assist in focusing on areas the college may want to move from acceptable to target. The dean highlighted Standards 1 – 4 and suggested Standards 5 & 6 be eliminated from the options since the college has limited control over the variables involved. The faculty then discussed the possibilities in small groups.
