USF St. Petersburg Administrators – Compiled from USF Directories and USFSP Commencement Programs

(NOTE: Period of employment and job title may vary from official HR records, due to publication of the USF Directory only once a year. There are also discrepancies in name spellings, conflicting (but related) job titles in multiple parts of the directories, and locations of USFSP departmental listings in the catalog itself. These peculiarities, of course, relate in part to the creative evolutionary process encountered by USF and USFSP, Florida's first regional campus in the State University System.)

USF Bay Campus was created on July 1, 1965 and the maritime facilities were used to accommodate 250+ students from USF Tampa's freshmen class (overflow was due to lack of dorm space). The students returned to USF Tampa the next year to complete their degrees.

Dr. Lester Tuttle came from USF Tampa in 1968 charged with building Florida's first regional campus in the State University System, as part of USF. The campus was designed for upperclassmen and graduate students, a compliment to St. Petersburg Junior College's freshmen and sophomore students. Herm Brames was the Center Administrator. Doris Cook was head Librarian. Wayne Hoffmann came in 1970. As we can confirm information about the years 1965-1971, it will be added it to this summary.
