Introduction to the Collection

In September 2003, Gabriel Cazares—former mayor of Clearwater and member of the Pinellas County commission—donated personal archives related to his service as a member of the Florida State Commission on Hispanic Affairs and his general leadership on Hispanic issues. This collection documents Cazares’s lifelong struggles on behalf of civil rights, human rights, and social justice (including his support of migrant farm workers). The collection represents the diverse voices of Florida’s Hispanic community, as well as Cazares’s many creative labors.

Introducción a la Colección

Gabriel Cazares, ex-alcalde de la Ciudad de Clearwater y ex-miembro de la Junta del Condado de Pinellas donó sus archivos personales relacionados con su trayectoria como miembro de la Comisión de Asuntos Hispánicos del Estado de la Florida y como líder en asuntos hispanos. Esta colección documenta el compromiso de Gabe Cazares por la defensa de los derechos humanos, civiles y de justicia social de la población en general y especialmente de los trabajadores migrantes del campo. Esta colección representa las diversas voces presentes en la comunidad hispana de la Florida así como el activismo del Sr. Cazares.

Biographical Note

A native of Alpine, Texas, Gabriel Cazares was born on 31 January 1920. He enlisted in the California National Guard in 1938, and entered the United States Army Air Corps in 1941. He served in the European theatre of operations during the Second World War, and later participated in the Berlin Airlift, the Korean Conflict, and the Vietnam War. A graduate of the Armed Forces Staff College in Norfolk, Virginia, Cazares retired from active duty in the United States Air Force (USAF) in 1966 at the rank of Lieutenant Colonel. He received the Bronze Star Medal in 1951, two USAF Commendation Medals, and a USAF Commendation Ribbon. Cazares attended Los Angeles City College and Fresno State College before completing his Bachelor of Arts degree in Sociology at Texas Christian University.

Mr. Cazares’s public and community leadership activities include his service as Mayor of Clearwater (1975-1978) and as a Pinellas County Commissioner (1980-1984). He participated in many government advisory committees and boards, including: the Bi-Racial Advisory Committee of the Pinellas County School Board, Educational Standards Commission of the Florida Department of Education, Florida State Commission on Hispanic Affairs, Florida Commission on Human Relations, Pinellas County Metropolitan Planning Association, and the Tampa Bay Regional Planning Council. His work with community and political organizations includes service as a member of the League of United Latin American Citizens (LULAC), president of the Clearwater Free Clinic, chair of the Pinellas County Democratic Executive Committee, a Golden Heritage life member of the National Association for the Advancement of Colored People, and charter president of the Northern Pinellas Democratic Club. “Gabe” and his wife, Velma Cazares, continued their commitment to social causes and community service long after his retirement from public office. They currently reside in the Countryside area of Clearwater, Florida.

Nota Biográfica

Gabriel Cazares nació en la ciudad de Alpine en el estado de Texas un 31 de enero de 1920. En 1938 se enlistó en la Guardia Nacional de California y en 1941 se incorporó a la Fuerza Aérea Americana. Luchó en la Segunda Guerra Mundial, la Guerra con Corea y Vietnam. Habiéndose graduado de la Escuela Militar en Norfolk Virginia, Cazares se jubiló de las fuerzas armadas como oficial de la Fuerza Aérea en

1966 con el rango de Teniente Coronel. En 1951 recibió la Medalla Estrella de Bronce. Gabe tomó clases en Los Angeles City College and Fresno State College antes de terminar su bachillerato en sociología en la Texas Christian University.

Como civil, el Sr. Cazares sirvió como alcalde de la ciudad de Clearwater entre 1975-78 y como comisionado en la Junta de Comisionados de la ciudad en 1980-84. Ha participado en muchos comités consultivos y juntas del gobierno como: el Comité Bi-Racial de la Junta Escolar del Condado de Pinellas, la Comisión Estatal sobre Asuntos Hispanos de Florida, la Comisión de Relaciones Humanas de Florida, la Asociación Planificadora Metropolitana del Condado de Pinellas y el Comité Regional de Planificación del Area de Tampa. Su trabajo con organizaciones políticas y comunitarias incluye: la Liga de los Ciudadanos Latinos Unidos (LULAC), presidente de la Clínica Libre de Clearwater, director del Comité Ejecutivo del Partido Demócrata en Pinellas, miembro "Golden Heritage" de la Asociación para el Avance de Personas de Color (NAACP) y presidente fundador del Club Democrático de Pinellas. Gabe y su esposa, Velma Cazares, continúan trabajando por las causas sociales y de servicio a la comunidad aún después de haberse jubilado como oficial público. Actualmente residen en el área de Countryside en Clearwater, Florida.

Scope and Contents

The contents occupy fourteen document boxes and one Princeton file (approximately 6.50 linear feet). Items fall within five distinct series: Biographical Files, Civil Rights, Hispanic Affairs, Farm Workers and Migrant Labor, and Clipping and Research Files. Most of the research and photocopies date from the mid-1970s through the late 1990s, though the collection does include materials from as early as the 1930s. The largest series, Hispanic Affairs, includes information about the Florida State Commission on Hispanic Affairs and general files that document Hispanic issues in Florida. Correspondence, agendas, meeting minutes, clippings, and government documents constitute the bulk of the collection.

Descripción de la Colección

Esta colección ocupa catorce cajas de documentos y un archivo Princeton (aproximadamente 6,50 pies lineales). El material se encuentra clasificado en cinco series distintas: Archivo Biográfico, Derechos Civiles, Asuntos Hispanos, Trabajadores del Campo/Migrantes y Artículos Varios y Carpetas de Investigación. La gran mayoría de las investigaciones y fotocopias datan entre 1970 y finales de 1990, aun cuando la colección tiene material que data de los años 30. La serie más extensa, Asuntos Hispanos, incluye información sobre la Comisión Estatal de Asuntos Hispanos de la Florida y archivos generales que documentan asuntos hispanos dentro del estado de la Florida. Cartas, agendas, minutas de reuniones, artículos de periódico y documentos gubernamentales constituyen la mayoría de la serie.

Language Note

Although most items in this collection are composed in English, some letters, memoranda, clippings, and other materials in this collection are only available in Spanish. Library staff may not be able to provide exact translations of some materials in the collection.
