- I. Minutes: The minutes of the November 19<sup>th</sup>, 2004 meeting were approved. Motion by Andy Reeves, seconded by Cynthia Leung. Carried unanimously. Minutes of the February 16, 2005 meeting were approved. Moved by Cynthia Leung, seconded by Andy Reeves. Carried unanimously.
- II. Timelines: The action items will be presented early in our meetings that the discussion items will be presented thereafter. Steve spoke with Deanna regarding time lines. We were informed that any items need to be submitted two months prior. CC meets the second monday<sup>th</sup> of the month; Grad Council meets the 15<sup>th</sup> and needs the material 10 days prior. Thus we need 2 months.

Graduate and undergraduate Councils thatn have to be considered in the matter of timing.

Special Education is proposing a Non-substantive change in the MAT program.

**Proposal:** The Special Education faculty would like to add a EEX 6943 Practicum in Exceptional Student Education. This would be taken during the second semester (fall term).

**Rationale:** The candidates need more mentoring support at this point in their preparation. The informal mentor that currently takes place in Pinellas Schools is inadequate. The Alternatively trained teachers are usually given the most difficult classes to teach.

**Request:** To approve the addition of EEX 6943 as a 1 credit requirement.

**Action:** Unanimously approved.

*Prima Facie* the committee believes that this is the type of change that needs to be made for the better of the program. In addition it doesn't appear to be a substantive change. Because Steve Micklo was at the meeting where this was discussed as a non-substantive change and does not involve a DOE change request, we approve it to proceed to the College Council. Steve will submit the request.
