Faculty on the University of South Florida (USF) Tampa, St. Petersburg, and Sarasota-Manatee campuses may submit research materials for inclusion in Digital Commons at University of South Florida and may revise their personal profile in [SelectedWorks](#) to highlight their research and creative works.

The following guidelines for faculty apply:

1. Any currently employed, permanent member of the USF faculty and any emeritus member of the USF faculty may work with the Libraries to establish a SelectedWorks profile that will showcase their professional work within Digital Commons at University of South Florida.
2. Adjunct or temporary faculty must have the agreement of their department head or college dean before establishing a collection within Digital Commons at University of South Florida.
3. The faculty SelectedWorks profiles may contain links out to other scholarly or University web pages, if desired.
4. Authors are responsible for ensuring that their works in Digital Commons at University of South Florida do not violate copyright. Any images included in the repository—individually or as part of a larger item—must comply with copyright. Content that doesn't comply will be removed by the Digital Commons at University of South Florida Team.
5. Faculty may select a Creative Commons license to attach to their submissions for which they still own copyright to make known their expectations for citation and use of their work. Unless advised otherwise, the default license attached to a submission will be CC non-commercial, no derivatives, 4.0. For more information, go to <https://lib.usf.edu/copyright/>
6. Faculty will work with the Digital Commons at University of South Florida Team to determine if any access restrictions or embargo periods may apply for selected deposits.
7. Materials may be written in any language.
8. The Digital Commons at University of South Florida Team will provide advice on file formats and file-naming conventions that are better suited for long-term preservation and efficient access. PDF files should be submitted whenever possible.

9. Audiovisual files, executable files, or files over 1 gigabyte in size should be discussed with the Digital Commons at University of South Florida Team before being submitted.
10. Through the Digital Commons at University of South Florida Team, faculty may submit a variety of scholarly materials as long as they meet the standards of the USF academic community. Examples of appropriate deposits include:
 - materials where the faculty member created or shared in the creation of the work and has the agreement of all other authors or creators
 - articles or post-prints of published materials when permitted by the commercial or academic publisher
 - abstracts of copyrighted publications, with full citations to the formal publication (no special permission is needed to deposit an abstract)
 - conference papers or presentations where copyright has not been transferred to a third party
 - course lectures or other course material that the author wants to preserve (as long as copyrighted material is properly cited and does not violate Fair Use guidelines)
 - technical or white papers/academic reports
 - research materials supporting scholarly publications
 - data sets
 - learning objects
11. Additional materials may be considered. Please check with the Digital Commons at University of South Florida Team to discuss other options. to discuss other options.
12. Digital Commons at University of South Florida is not intended as a storage space for works in progress. The Digital Commons at University of South Florida Team may be able to suggest appropriate options for storing and accessing temporary works.
13. Digital Commons at University of South Florida is not a suitable storage space for non-scholarly or personal photos, images, or other content that should otherwise be stored on a private web site or server.
14. Faculty will not be able to revise or update items once submitted except to correct significant factual errors or unintentional copyright, policy, or legal violations.
15. The USF Libraries retains the right to remove or restrict access to materials that are deemed in violation of copyright, the Libraries Digital Commons at University of South Florida Guidelines, University policies, or State or Federal laws. The Libraries will notify authors when such steps are taken.
16. The Libraries maintains a faculty member's profile as long as the faculty member is a USF employee. If a faculty member leaves the university, the faculty member's profile will no longer be affiliated with the Libraries. If the faculty member joins a university with a subscription to bepress Selected Works, the profile can then become affiliated with the new institution.
