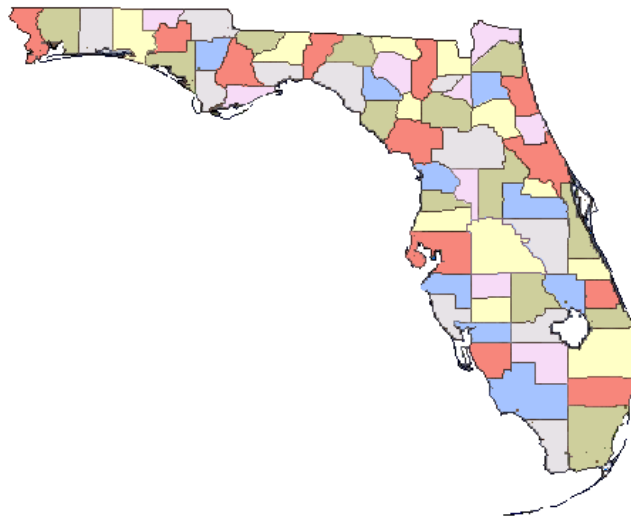

Introduction to the Collection

In the summer of 2003, Donald J. Ivey—an archivist and published historian—donated research files he compiled and chronological biographies he created during his tenure as curator of collections at Heritage Village in Largo. These materials reflect Mr. Ivey’s interest in Florida’s political history, and include two large document boxes and eight standard document boxes with chronological biographies, clippings, photographs, and other research materials on notable Florida political leaders.

Preservation Note

Provenance of the Donald J. Ivey Research File

This collection falls under the Local and Regional History provenance of the Special Collections and Archives department, Nelson Poynter Memorial Library, USF St. Petersburg.

Scope and Contents

The contents occupy ten document boxes (approximately 5.6 linear feet). Items fall within three distinct series: Chronological Biographies, Biographical Research Files on Individuals, and a Prosopographical File on the Office of the Lieutenant Governor. Most of the research and photocopies date from the mid-1980s through the late 1990s, though the collection does include a substantial number of microfilm copies of newspaper articles and documents from the nineteenth century. General materials found in the research files include photographs, correspondence, government documents, copies of deeds and legal instruments, and directory and biographical information. Four notebooks in the Chronological Biographies Series represent fictional accounts based upon historical events, and three of them have no direct relevance to Florida politics and government. They do, however, illustrate how a student of history can craft historical fiction by examining the context of the times and engaging in scholarly research.

Additional Sources of Information

Many repositories, libraries, and archives collect materials related to local political leaders. Please consult with the special collections or reference librarian if you require assistance locating primary source materials for a particular subject or person. Don Ivey donated a similar collection of political research to the Heritage Village Library and Archives, located in Largo, that may also be of interest to the researcher.
