Staff Meeting Feb. 25, 1998

HE TOLD US THAT ANY ACTION THAT INVADES A PERSON'S PROPERTY AND OR SPACE IS NOT REQUIRED TO BE DONE BY A USF EMPLOYEE. HE DID NOT ADVISE GOING INTO A PATRON'S POCKETS, EVEN UPON REQUEST, THOUGH GOING INTO A KNAPSACK OR HELPING A HANDICAPPED PATRON PUT ON GLASSES WERE JUDGEMENT CALLS UP TO THE INDIVIDUAL EMPLOYEE. FOR TASKS THAT AN EMPLOYEE DOES NOT FEEL COMFORTABLE DOING LANNY FELT IT WAS FEASIBLE FOR A LIBRARY EMPLOYEE TO POLITELY INFORM THE PATRON THAT IT IS AGAINST THE POLICIES OF THE USF LIBRARY TO GO INTO THE PERSONAL EFFECTS OF OUR PATRONS. IF THE PATRON PERSISTS THE EMPLOYEE IS ADVISED TO SEND THEM TO EITHER TIM IN STUDENT AFFAIRS OR TO LANNY.

- ◆ THE IDEA OF CREATING MULTIPLE "NICHE" LIBRARIES BASED ON SPECIFIC SUBJECTS

SOME OF THESE CHANGES ARE EXPECTED TO BE IMPLEMENTED BY THE MIDDLE OF THE UPCOMING FALL SEMESTER.

THIS FALL WE ARE TO SHARE CAMPUSES WITH THE STUDENTS OF ST. PETERSBURG JUNIOR COLLEGE. BEYOND THAT, LANNY REPORTS, NO ONE IS QUITE SURE WHAT WILL HAPPEN.
