Introduction to the Collection

Sandy Oestreich and May Hainisch, two longstanding members of the Pinellas County Chapter of the National Organization for Women (NOW), donated a variety of research and subject files from their leadership of the Pinellas NOW chapter to the Special Collections and Archives of the Nelson Poynter Memorial Library. The general organizational records, advocacy files, and program files illustrate the local NOW chapter's involvement in a variety of issues, including advocacy for reproductive rights and criminal justice reform, preventing sexual harassment and violence towards women, and supporting the passage of the proposed Equal Rights Amendment. *Nota bene:* This collection represents the records collected by Oestreich and Hainisch during their service to the Pinellas Chapter of the National Organization for Women, but these materials cannot be considered the complete institutional record of the Pinellas NOW chapter.

Preservation Note

Provenance of the Pinellas NOW Papers

This collection falls under the Local and Regional History provenance of the Special Collections and Archives department, Nelson Poynter Memorial Library, USF St. Petersburg.

Scope and Contents

The contents occupy eight document boxes and one oversize newspaper box (approximately 8 linear feet). Items fall within five distinct series: General Organizational Records, Electoral Advocacy, Legal and Social Advocacy, Programs and Public Events, and Other NOW Chapters and Affiliates. Most materials in this collection date from the late 1970s through the late 1990s. Organization records, agendas, meeting minutes, clippings, and subject files constitute the bulk of the collection. The library received the original accession in 2003 and a subsequent accession in the fall of 2004.
