1. **Call to Order** – The President called the meeting to order at 10:11 a.m.
2. **Meet and Greet** – Alonzo Favors of Operation & Maintenance of Facilities was introduced by Linda Green.
3. **Minutes from 06/21/06 Meeting**
4. **Council Officers**
  - As previously stated in a separate communication, the deadline to submit nominations for the offices of Vice President and Secretary was extended to Friday, June 30, 2006. A total of two nominations were received, one for Vice President and one for Secretary.
  - Consequently, a motion to set aside Article 5.1b and c of the Bylaws was introduced and passed unanimously. The two individuals running for each office were appointed without opposition.
  - Congratulations to our new Vice President, Terri Johnson, Accounting & Financial Services, and our new Secretary, Lori Anderson, Parking Services.
  - Thanks to our outgoing Vice President, Brandi Heinrich, and Secretary, Michele Holton for their service to the Council.
5. **Classification Redesign (PDQs)**
  - This initiative is still being staffed by Dr. Carlucci w/Cabinet level officers.
  - Another reason that it has not progressed any further is because of Union negotiations.
  - Currently filled positions are not being reclassified unless the department is being completely reorganized.
  - New performance appraisal forms are now available to use for future evaluations.

  - Students will be moving into RHO on Wednesday, August 23, 2006.
