Introduction to the Collection

Dr. Jean Chance, a retired professor of journalism, joined the faculty of the University of Florida (UF) in 1969. During the late 1980s, while serving as an associate professor in the UF College of Journalism and Communications, Chance received a sabbatical to research Henrietta Poynter's influence and leadership at the *St. Petersburg Times* and *Congressional Quarterly*. This collection includes research files, notes, and photocopied documents collected by Chance during her sabbatical, as well as a paper delivered at the 1989 meeting of the Association for Education in Journalism and Mass Communications (AEJMC). In addition to her work in the classroom, Chance held appointments as chair of the University Senate and the UF Intercollegiate Athletic Committee. She retired from her fulltime assignment at the University of Florida in May 2003.

The two document boxes of correspondence, public documents, clippings, and other research materials were received from Professor Chance through David Shedden, library director at the Poynter Institute. The Nelson Poynter Memorial Library took possession of these materials in May 2004.

Biographical Note: Henrietta M. Poynter

The following biographical note is based upon research by Professor Jean Chance:

A native of New York, Henrietta Malkiel was born on 25 April 1901 to Russian Jewish immigrants. She attended public and private schools, including Hunter College High School. During the early 1920s, she earned an A.B. degree from Columbia University. Shortly thereafter, she became a dramatic and feature editor for popular magazines, including *Vogue* and *Vanity Fair*. Between 1929 and 1931, Henrietta became the foreign editor at *Vogue*. She became a freelance writer and took part in theatrical production activities in New York and Paris during the early 1930s, later serving as a talent scout, artist, and writers' manager. By the beginning of World War II, she worked as assistant chief in the program division of the agency that later became the Voice of America. She served as assistant to Director John Houseman, an actor and producer best known for his dramatic performance as Professor Charles W. Kingsfield, Jr., in the acclaimed movie and television series, *The Paper Chase*.

Henrietta Makiel married Nelson Paul Poynter on 8 August 1942. They exchanged vows in Williams, Arizona, while Poynter had taken leave from the *St. Petersburg Times* to serve as chief of the Office of War Information's Movie Bureau in Hollywood, California. Upon returning to St. Petersburg, the Poynters were frustrated by the difficulty they had in obtaining timely and accurate information about political activities in Washington, D.C. In an attempt to develop a clearinghouse for information that would assist them with their duties at the *St. Petersburg Times*, Nelson and Henrietta Poynter co-founded Congressional Quarterly Incorporated. They co-edited issues of *Congressional Quarterly*. In 1953, Henrietta assumed responsibilities as associate editor of the *St. Petersburg Times*. The following year, she became vice president and trustee of the Poynter Fund.

Henrietta Poynter passed away on 26 January 1968. She suffered from a stroke. In April of the following year, the Florida Legislature honored her in passing resolutions that commemorated her as "one of the nation's leading authorities on the United States Congress." Her husband died on 15 June 1978, shortly after attending dedication ceremonies for the expansion of the University of South Florida St. Petersburg campus.

This collection falls under the Journalism and Media provenance of the Special Collections and Archives department, Nelson Poynter Memorial Library, USF St. Petersburg.

Scope and Contents

The contents occupy two document boxes (approximately one linear foot). Inclusive dates cover the mid-1930s to early 1990s, with the bulk of the material covering the period from 1978 through 1989.

Contents: Includes a 26 August 1987 obituary from the *St. Petersburg Times*.

Contents: Published materials about Henrietta's mother, a Jewish sweatshop worker in New York City who later became a labor leader.

Contents: Photocopied legal documents, clippings (pre-divorce), and correspondence about Catherine Ferguson Poynter and Nelson Poynter. Catherine Poynter, later remarried as Catherine Stephenson, organized local women into a group which later developed into the St. Petersburg League of Women Voters.

Contents: Correspondence between Nelson and Henrietta, as well as clippings and other materials announcing their summer 1942 wedding.

Contents: Clippings, biographical directories, notes, and other items that document the activities of Henrietta Poynter. Also included is a timeline created by Chance.

Contents: Clippings, correspondence, and notes related to Henrietta Poynter's declining health, death, and estate.
