- USFSP received an update from Representative Bill Heller concerning the latest information on property tax and insurance.

- A Child care work group has been established in order to assess campus needs in the area of quality, affordable childcare for children of staff and faculty. A survey of your concerns might be the best way to collect needed data in order to assess the feasibility of supporting the building of a center on campus or a partnership with an existing childcare facility such as All Childrens or Bayfront.
- A motion was made and seconded on sending out an email inquiry to move the time and/or date of USPS meetings. Because of conflicting office demands and training seminars, a suggestion was made to change the day from the third Wednesday of each month to Friday.
- A brief discussion regarding the change of title from USPS Council to Staff Council in order to reflect changes on recent implementation of classification redesign has been tabled till next meeting.
- A feasibility question was raised as to whether or not USFSP would like to have a 'Quiet Quality Monthly Award'. Please respond by email to Mike Williams. For those wishing to nominate an employee for the current 'Quiet Quality' award, remember that anyone can nominate a person in any department as long as the nomination is substantiated in writing.
- The Council is reviewing the Annual Awards program and plans to submit recommendations for improvement to Human Resources by June 15<sup>th</sup>.
