College Council Minutes
Called Meeting – Sept. 19, 2003

Members Present: Guda Gayle-Evans, Steve Lang, Terry Rose, Deanna Michael, Barbara Frye, Bonnie Braun. **Ex Officio Members Present:** Dean Vivian Fueyo, Robert Egley-Faculty Council Liaison.

Meeting called to order at 10 AM by Chair Guda Gayle-Evans.

New Business: Members of the Council decided that the COE Faculty Council representative shall be considered an ex officio member of the College Council and designated as "Liaison."

Council members decided that Chairs and Vice-Chairs of the various council committees should be elected by the committee membership. Furthermore, these positions should not be limited to only tenured faculty.

Tenure and Promotion: Steve Lang reported on the USFSP COE Tenure and Promotion Guide. The scope of this document was broadened to include: (1) the importance of Clinical Supervision & Training, (2) the viability of electronic journals, and (3) evaluation documents created by the faculty member. Council membership voted to accept the USFSP template currently in use for those faculty members who are in the process of tenure for fall, 2003.

Dean Fueyo discussed a draft document pertaining to COE procedures for Tenure and Promotion, which she had written. Members discussed the "Appeals Process" contained in this document. It was recommended that our Faculty Council Liaison bring this issue up at the next campus-wide Faculty Council meeting. Dean Fueyo also recommended the inclusion of tenure-earning faculty on the Tenure and Promotion Committee. Council members voted to accept the USFSP T & P procedures for Fall, 2003, while realizing that this document is still in draft form for purposes of allowing the faculty members currently up for tenure to move forward. Council also voted on an amendment to this motion to include only #3 in "Appeals" section. Dean Fueyo will make these changes and forward to the Council membership.

Council membership also approved a vote to move mid-tenure review to Spring semester.

The Vice Chair of the Council, Terry Rose will solicit nominations for a non-tenured, ex officio member to this committee.

COE Constitution: Although the COE Constitution Ad Hoc Committee had completed its draft and was ready for presentation to the Council, this discussion was tabled. Dean Fueyo would like the opportunity to meet with the committee regarding her suggestions.
