Senator Kiger- *Motion to postpone, accepted.*

**Legislative Announcements:**

Senator Kiger- We had a meeting at Monday at noon in the conference room. We looked over the Executive Branch Structure and it was approved which means it will now go through Senate. If you would like to join my committee then please feel free to talk to me.

Senator Toro- JEC has not yet met. The first meeting is 10:30 on Thursday in the conference room. Something that I said I was do when I was running was provide the grievance form online so every can file it out, and it has been done.

Senator Gao- Appropriations meets Mondays at 2:00 in the SG conference room. There was no business this past meeting but the next meeting is June 6<sup>th</sup> and we have a few things to discuss. Christy Brinkworth ran unopposed and is now the new Vice Chair. If you would like to join my committee then speak to Rachel Brown, although it is kinda filled.

Senator Sandoval- University Affairs meets Tuesdays from 3:00-4:00. Our Vice Chair is William Warmke, who is also Sergeant of Arms. We are going to have a great semester and this summer we will be creating lots of surveys.

Senator Aziz- Tomorrow is the Community and Government Affairs committee from 12:00-1:0. If you want to join then feel free to come. We will be going over the agenda and goals for the semester.

Senator Hemani- Programming and Audits meets Mondays at 11:00. Our elected Vice Chair is Naseem Akel. We also had pancakes, so yes I might entice you with snacks once or twice a month. If you would like to attend then please join the committee. Also Signature Event applications are due on June 24<sup>th</sup> so please inform your friends and let student organizations know so they can apply.

Pro Tempore Brown- Thank you for those who came to the new Senator orientation. I hope that it will make your first meeting easier. Anybody that is not on a committee please come and talk to me after the meeting. If you are appointed and are not yet receiving emails then let me know. Everyone should have gotten the agenda yesterday. If you would like to join another committee I will add you to the roster. Welcome everybody!

Senate President Hassouneh- First, about an hour ago we informed Senate Clerk Rerucha that she will stay on and our new secretary will be Theresa Rivera, former Student Life and Connections. Theresa will be in committees and Rerucha will be in the chambers. We are initiating Adhoc committee hearings via email. So if you can volunteer to be on one of these committees then please do, we encourage everybody to be on at least one. The first committee will cover things such as budgetary practices, education reform, and they will tweak current processes on budget and travel for all student organizations. Our goal is to educate beforehand what is eligible for funding and what isn't. The Chair for that is Senator Gao and the Vice Chair is Senator Toro. Gil Ivan- That's just a quick apology because they are in DC for a policy conference. This Thursday at noon we will have a stuffing party. We will be filling bags with material that will be ready to give at orientation to incoming students. We started this last year and we would love any help that we can get. We have over 5,000 bags to stuff with flyers, lanyards, pens, and other stuff. I have sent an email out to Hassounch in regards to the stuffing party as well as time slots in which we need volunteers to work the table at orientation. In previous years we have been out there but this year we will be out there a full month for all 13 sessions with 2 days each. The email will have a link that's in nice googledoc format that you can easily fill out. If the spots do run out let me know so we can work something out. I have marketing out there a lot and we can switch new Senators out with them. We also have an orientation briefing for those of you who have never done this before and don't know what to expect. I have been here for 3 years answering questions and I will always be at the booth so I will be there to guid you. Other than that we have 2 great candidates up for confirmation tognight. Are there any questions?

Seantor Aziz- When is the orientations?

Gil Ivan- Orientation runs on Mondays from 1:00-7:30 and Tuesdays from 10:00-4:00 and then Thursdays and Fridays on the same schedule. June and July everybody will definitely be in orientation mode.

### **Judicial Branch Report:**

Justice Robert Then- We had a full court but then we had 4 members graduate and 2 have been excused from the summer term. Our first meeting is this week at 6:30. We meet bi-weekly, followed by parking appeals. Once Diaz puts the applications out then please have your constituents apply. Despite what Hassounch may say, if you are interested in joining the court please apply. I started off in Senate as well. It's a good opportunity and there will be a lot of things planned.

Senator Saunders- How many active justices are there?

Justice Robert Then- There was 5 but I have excused 2 for the summer for different reasons.

### **Open Forum:**

Senator Hughes- Hello and welcome to the new Senators. It's a little tense in here, so please breathe. A lot of you are dressed so nicely, but its summer and hot so I decided to not dress up. Anyway I just wanted to say that I look forward to serving you all.

Senator Toro- Before we begin I just wanted to bring up that there are no job descriptions in the packet. Can I give a formal request to pull it up on the computer so we can see it?

### **General Business:**

Senate President Hassounch: In the future we aren't going to have paper copies in Senate. So please bring your laptops because we will only have a few copies. Tonight you guys might have to share. Copies of the job descriptions are on the way because you don't have them. You should get them before we got to Q&A.

Gil Ivan- Hey everybody, again. Here we have Adrianna Santos for Chief Financial Officer. Here's just a quick glance of the process for everyone. We had 16 applications in 10 business days with 6 candidates responding in which we contacted 4 for interview. 3 of those accepted and we felt that Ms. Santos was most qualified with her previous work with SG and other university entities in the past. Miss. Santos was deemed the most qualified to fulfill the job duties of the office based on her extensive knowledge of Title 8 Finance Code and Proviso, her knowledge and experience with university purchasing guidelines and operations of the A &S Business Office, and has valuable experience managing and advising both in Student Government and within other A&S funded programs. In addition, Miss. Santos demonstrates the strong communication skills and high integrity necessary to be successful in an advisory and financial officer role.

Adrianna Santos- Hi everybody, I'm Adrianna and I'm going for appointment. I am a biomed major with a minor in leadership. My GPA is a 3.72 in the honors college. I have had numerous leadership positions with ADHD research, and collaborative extra curricular programs. For the past 2 years I was the Director of Promotions for Dance Marathon, a 17 hour event that rose over \$27,000. I also participated in the emerging leader's development conference. In addition I volunteered at All Childrens Hospital and a womens health clinic that offered free health care and organic gardens. I also have SG experience as the Deputy CFO under Zach Johnson, and I was an ASRC chair with Rachel Brown. Some of my previous work experience is a sandwich artist at Subway, waitress at Steak and Shake and Acropolis and currently I baby sit. What I intend to do is be a strong resource for students to go to. I would like to get more people involved with Signature Event grants and provide that strong pillar for advice in the community. In addition I would like well written budgets in which I plan to work with Senator Toro and the A&S office. I want Bulls session to be more interactive, informative, and ready to present budgets to a strong committee. With the Deputy CFO I plan on helping them learn the ropes and create POs purchases in a quick and timely manner so the office isn't confused. I think that I am the best candidate for this position because I am highly organized and have high integrity. Mr. Hassounch just created a Commitment to Honor and as a

person in a high position I believe it is important to be a person of high integrity that you can trust. They need to be somebody that you can have an open door policy with, to talk to them about anything and what I do as CFO. I am familiar with Title 8 and provisio, I am familiar with creating ASRC budgets, I am familiar with pay scales, and Zach has given me multiple projects to create budgets so I am good with excel. Are there any questions?

Pro Tempore Brown- How many credits do you have in the fall and what classes are those?

Adrianna Santos- It is either 14 or 16. I am taking my honors thesis, human anatomy, bio chemistry and lab, as well as 2 leadership courses.

Senator Farrell- You mentioned that you felt you were good for this job. Beyond the daily tasks of CFO, how do you see yourself fit?

Adrianna Santos- The CFO should be well rounded and make budgets and payroll. They also need to interact with student organizations and be kind of social. We have a strong culture at USF with different things such as the OUR shirt, and engineering sustainability practices. I would like to continue with that.

Senator Toro- What are your commitments outside of class and SG?

Adrianna Santos- None, because next year I won't be doing Dance Marathon. I do have my 4 hour research commitment that I would continue.

Senator Belmont- In regards to SG purchases and cost effectiveness, what would you say your philosophy is in regards to quality or quantity?

Adrianna Santos- In the beginning it's about being economical, what is the program for and what product is being used. You have to look at the big picture and see if it will last long in the future.

Senator Gao- What do you hope to gain being CFO?

Adrianna Santos- More networking skills. I believe I wasn't quite ready for the committee last year and in SG I would like to create a strong program. In addition I would like budgets in on time and purchases to run smoothly.

Senate President Hassouneh- The Sergeant of Arms is passing out the job description now.

Senator Aziz- What problems did you encounter as Deputy CFO?

Adrianna Santos- There was communication barriers between Zach and me because we weren't in the office at the same time. I also had a problem with Homecoming grants because I didn't realize how much time and effort was put into communicating with 20 different student organizations.

Senator Saudners- How long were you Deputy CFO?

Adrianna Santos- I was Deputy CFO from July 2010 to April 2011.

Senator Saunders- Can you give us some examples of what you did as Deputy CFO?

Adrianna Santos- I did payroll, purchases for marketing with street team, homecoming grants, and I also contributed to 5 or 6 Signature Event grants and getting everything confirmed with that. I was Zach's right hand man and helped create budgets and was a member of ASRC.

Pro Tempore Brown-In regards to the Homecoming Grant issue. I personally dealt with student organizations that had problems down to the last week. What are you going to do to be in the office more since you are the only person they interact with?

Adrianna Santos- The minute we get the list of student organizations I will first email them and then make phone calls because sometimes emails get lost in transition. I would ask them if they had any questions and then make them aware of the purchasing policies and the 5 day window. Last year I got burdened down and I don't want to make the same mistakes that I did.

Senator Toro- In statutes it states that we have to evaluate the effectiveness of our policies, procedures and techniques. How do you hope to accomplish that?

Adrianna Santos- I would help fulfill their goals with strategic plans for Student Affairs and SG. People need to know what is going on and what they want their goals to be. We have to hold them accountable for what they do and say and have an open communication window.

Senator Gao- With SG events, student organizations would put POs in with the business office. What would be the difference of giving it to you and the A&S business office?

Adrianna Santos- It elevates the pressure on them logistically. I have done this in past so I know where they can get the product from and it helps with their planning. It's the same system just a different account through me, whereas special events would be under a student organization account.

Senator Toro- As CFO you would sit in on ASRC this year. What was your biggest contribution to ASRC when sitting in for Zach.

Adrianna Santos- I am very easy going and positive. I was just learning so a lot of times I didn't say anything. I like to think that I was a good voice of reason and that I was levelheaded if that was anything with payroll. I was mostly learning though and not really contributing.

Senator Hemani- You stated that there was a communication barrier last year. How would you hope to break it?

Adrianna Santos- I would have the Deputy CFO commit to a schedule. If it says on their calendar that they are going to be in then they need to be in their office. That was the miscommunication last year. Also emails need to be answered in a time manner to not let things build up over time.

Senator Gao- *Motion to discuss*

Pro Tempore Brown- *Objection!*

Senator Gao- *Resend*

Pro Tempore Brown- *Motion for a 15 minute moderated caucus with a 1 minute speaking time, accepted.*

Senate President Hassouneh- Does everybody have a copy of the job description or do I need to put it up? If you have a copy and you don't need it then please pass it on and share. For those that are new, you will get 1 tap of the gavel for 30 seconds, 2 taps for 15 seconds, and 0 seconds I will gavel you out of order.

Pro Tempore Brown- As Miss Santos mentioned I worked with her and I do have concerns because of it. She kind of downplayed the whole Homecoming grant experience. I had several organizations saying they couldn't get in touch with her because she was never in the office. I do have concerns with her because we are the face of that and we want to have a positive impression. I understand ASRC can be scary at first but it shouldn't take an entire year. At the very end she was very concerned about a certain subject but never even spoke up about it.

Senator Suanders- My only reservations are playing off Pro Tempore. That seems like a lot of classes with an intense amount of homework. I think that her being in the office is important and I don't see her being able to do that. That is my biggest reservation.

Senator Belmont- I sat on ASRC last year and she didn't speak at all. Even when she was representing Zach she didn't do her job. She admits that she had a communication barrier with her future boss. If she didn't have good communication last year I don't see how that will change. My question with cost effectiveness, she didn't even give me a clear answer. I wanted her to say that she wanted to purchase as much for the students as possible and she didn't.

Senator Toro- In regards to Zach's email... Her knowledge of provisio is a 3 page document and title 8 isn't difficult either. That knowledge is the same that any student organization has and there are over 250 of them. Her demonstration of strong communication is subjective. Wilson motion to close moderated caucus and move to vote by roll call

Senator Gao- *Motion to vote by roll call, accepted.*

Senator Belmont- I was not called.

**Final Count: 5-33-1, Nominee not confirmed.**

Senate President Hassouneh: The problem with having only one exec officer here is that we have to wait

Senator Saunders- Is there any documentations for this candidate?



Senate President Hassouneh- It is being passed out right now. Goff is recognized and Ivan will introduce him to you guys. You should be getting a copy of the job description, paperwork, and he has a powerpoint.

Gil Ivan: Hello again for the 3<sup>rd</sup> time. Before you is Brian Goff who is up for appointment for Attorney General. There were a total of 17 applications were received during the 10 business day period in which the applications were available and marketed. All applicants were emailed questions to learn further information, of which five of those candidates responded. Four candidates were contacted for interviews, all four accepted the invitation and were interviewed. Mr. Goff was deemed the most qualified to fulfill the job duties of the office based on his experience sponsoring amendments within the Senate Committee on Rules, his understanding of the day to day operations of the Judicial Branch from serving as Judicial Liaison of the Senate, prior Student Government court experience partnered with his activity in the Mock Trial Club at USF, and his drive to positively impact various branch operations. In addition, Mr. Goff is dedicated to service and upholding a high level of integrity and justice necessary to be successful as the legal advisor for Student Government. I have seen Goff in the office since his appointment and he interacts with everybody in a positive manner. I think he is a great candidate for this position.

Brian Goff: Hello everybody. I'm the nominee for Attorney General. Before I begin I want to congratulate everyone and apologize for not being around more for the 52<sup>nd</sup> term. I served in the 51<sup>st</sup> term and I can guarantee it only gets better from here. Here's a little about me; I was born in Tampa so it was only fitting that I came back here. I am 20 years old and a junior with my major being biochemist and a minor in biochemistry. I know the questions that Senate usually asks so hopefully I can cover them with this presentation. I am taking 6 credits this summer, my classes are genetics and cell biology. In the fall I have 14 credits but 3 of those I've already done. Some extracurricular activities that I've participated in are mock trials with UF and UCF as the competing schools. We had a civil case about a child who died and our team qualified to participate in the regional level tournament. Through this I was able to interact and witness the demeanor in which to interact with a judge. I will be the vice president for the honors college and I was in student council in which I had to chair and delegate. Here's my involvement for SG. I was a senator for the 51<sup>st</sup> term where I served on appropriations committee and the judiciary and rules committee. I helped write bills. I was also the Sergeant of Arms for one meeting before Mr. Warmke took that for me. I was the judicial liaison. I met with the MSC board with Janet Rojas and I worked with her in the office of Legal Affairs. What I hope to do when I'm in the office as AG. I would hope to continue with free legal aid and I have been in contact with Ms. Judy and Rojas and they have already had students contact them about it. Last year we started a free tax service and that went really well so I would hope to continue with that. Something I would like to begin is a program where we could look over student's leases so that they aren't getting nickled and dimed. A big thing is that I want to protect SG's interest and ensure we aren't doing things we were not supposed to be doing. That's what AG is supposed to do. Last year was a good year and I would like to continue with that. One of Matt's and Zach's goals is to build a sense of community and tradition and I want to do that by

making sure I'm out there with Matt and Zach. I want to ensure that students at USF are getting the best college experience possible. That's about it. I would like to thank you in advance.

Pro Tempore Brown- You mentioned you did an audit for students on business. What did that entail?

Brian Goff- I tried to do a third party. I met with them to know the reason why they were there and their inputs. What came out in the end is I wanted to know how theirs worked, their summary, and if ours ways good or not.

Pro Tempore Brown- Can you explain how that is relevant to the office of legal affairs?

Brian Goff- I went to Rojas and that's what she asked me to do. Adam Check was interested and Janet saw that as an opportunity to work with the office.

Senator Belmont- You mentioned interim communication between the branches. What mechanism do you have in place?

Brian Goff- Make sure everyone is open with emails, have an open office policy, and not get mad over petty little things that might interrupt student experiences at USF.

Senator Saunders- I know you have experience with writing legislation but what are some examples that you have written in statutes?

Brian Goff- For those of you that passed Solicitor General in chapter 303, it's a student that helps students with parking appeals and myself and Mr. Hassounch created that and made changes to chapter 102 which involves breaking statutes. Those are just a couple of examples.

Senator Wilson- I'm worried because you're taking 14 credit hours and that's a heavy course load for this position. How would you ensure your availability?

Brian Goff- I should have put my week at a glance here for you guys. Monday and Tuesdays I have a huge gap in between my classes. My schedule is set up to where there peak time that I'll be here. We will also have the Deputy AG and solicitor. I get emails to my phone and I don't have a problem giving my cell to students and Senators.

Senator- What do you see your role as a student general?

Brian Goff- I ensure to SG that as a whole I will protect and not get us into trouble. We have to look good to the student body enforcing statutes, rules and constitution.

Senator Aziz- Based on experience what type of student or problems would you foresee in your office?

Brian Goff- I would only see student from campus coming to me as a last resort. If they had financial problems they would go to appropriations. My office would be for parking appeals and stuff like that.

Senator Kiger- What do you hope to gain from this position?

Brian Goff- I would like to network and get myself out there like I did last year. Foremost I would like to develop a sense of commitment like Matt and Zach's big picture.

Senator Saunders- One of your job duties is providing legal opinion. Do you have a strict or loose interpretation?

Brian Goff- They asked me that in the interview process. It really depends on the statute and whether it's black and white or if there are some grey areas. We had to write a legal opinion for a grievance for campaigns and it was stricter. The question was can they file a grievance without evidence. The answer that I chose is that they can but there isn't really any reason to because we would have to throw it out without any evidence.

Senator Toro- How familiar are you with the ethics statutes besides your experience with legal writing?

Brian Goff- I wrote a legal opinion for my interview, last year I sat in on the legal branch and they had to write opinions as well, since I have gone into appointment I have looked through memorandums within the last 2 terms to get familiar with them.

Senator Carpenter- I see you're a biochem major. What sparks your interest in law?

Brian Goff- I have been interested in politics since High School. One of my goals is that I want to be a doctor without orders really bad. I want to go after grad school to help people dealing with the genocide. I want to help the community globally with medicine versus being a lawyer. That's why I jumped into Student Government.

Senator Toro- Since as AG you would have to represent the student body. How would you respond to a situation with conflict of interest or bias?

Brian Goff- That's why I would have a Deputy AG. I feel if my bias was too strong then I would allow my Deputy AG to serve in that case.

Senator Wilson- *Motion to close questioning and move to discussion.*

Senator Aziz- *Objection!*

Senator Wilson- *Resend*

Senator Aziz- I saw from your presentation that you wanted to continue with free legal aid and tax services, how effective were they last year?

Brian Goff- Extremely effective. Rojas was down there for the free tax service and like I said I have already gotten emails for legal aid. I want to further and continue both of those. Our goal is to carry legal aid and I want that option available.

Pro Tempore Brown- Do you see your role for SG as a whole or the exec branch only?

Brian Goff- As a whole, not just for the executive branch. Students need opinion and I am here to represent SG as a whole.

Senator Gao- I had to deal with legal aid in terms of I tried to set up an appointment. The lawyer couldn't meet with us ever, how would you solve this issue?

Brian Goff- That's important. We will constantly be evaluating the attorneys that are coming in and help the students have that service available to them.

Senator Toro- How would you react in a situation if a conflict was brought before you and your opinion was needed but found conflicting statutes?

Brian Goff- I was also asked that in the interview. I would sit down with both sides. There are always 2 sides to every story and if the statutes need to be revised then we can do that. It really depends on the statutes and what the conflict is.

Senator Wilson- *Reinstate motion to close questioning and move to discussion.*

Senator Toro- *Objection!* I would like to make a moderated caucus.

Senator Wilson- *Resend.*

Senator Toro- *Motion for a 15 minute moderated caucus with a 1 minute speaking time, accepted.*

Senator Wilson- I know that he hasn't been here a long time but he has always been heavily involved and known as the sketchy guy in the back. He is good at scheduling his schedule out. Obviously he is very passionate. I know he put himself on the line with the whole Solicitor General position but obviously he's not applying.

Senate President Hassouneh- Reminder that 1<sup>st</sup> tap is 30 seconds and 2<sup>nd</sup> tap is 15 seconds.

Senator Toro- I have nothing but the most respect for him. I think he is very intelligent but his lack of experience writing legal opinions worries me. He has only been a Senator for 6 months.

Senator Shields- I think he has it put together. For all the questions he was on top of everything. I didn't know he was a senator for 6 months and he was so involved that alone he is willing to step up and be involved.

Senator Gao- *Motion to close moderate caucus and move to roll call vote, accepted.*

**Final Vote Count: 30-7-2, applicant passed.**

Senate President Hassouneh- Congratulations!

*Oath given by Hassouneh and taken by Goff.*

Senator Saunders- Is this time sensitive?

Senator Hassouneh- Yes. This is the only time you will get a hard copy, so please read legislation ahead of time.

Senator Kiger- Please take a minute to look it over if you haven't yet. As far as exec goes, Diaz and Johnson brought this to use and had a couple of positions that are no longer on the legislation. After careful discussion we requested they removed a couple more positions on the committee. Rules looked it over yesterday and it was voted to be sent to the floor. It was passed unanimously.

Senate President Hassouneh- It can only be amended in the committee and not on the floor.

Senator Toro- Please remind me what chapter 807 is.

Senate President Hassouneh- It's the outline for funding in SG positions and what can be funded and the rules pertaining to.

Senator Aziz- What positions were removed?

Senator Kiger- One was with student life and the other was the executive clerk. They made a second assistant executive director.

Senate President Hassouneh- This is new entirely. This was removed this year and has nothing to do with the Hernandez structure.

Senator Belmont- *Point of inquiry.* Does Hassouneh support this, since you can't participate in discussion or vote on it?

Senate President Hassouneh- I initially received this two weeks ago. We dealt with the problems that came up last year. We cut a few positions because every year the executive branch grows. We kept in line 26 positions. Initially there were 29 and we cut the 3 that we suggested. I have no reservations contingent upon funding. We made a committee executive budget as a whole in ASRC and we will not be providing additional payroll.

Senator Belmont- *Move to discuss accepted.*

Senator Uhler - Where does the Solicitor General fall under this?

Senator Kiger- It doesn't fall under chapter 305.

Senator Toro- *Point of information.* The executive branch structure has 6 mandated positions. Those go in chapter 303 in chapter 305 every year there is a new one because they are replaced with the new exec structure.

Senator Gao- *Motion to discuss with moderated caucus of 5 mins with a 30 second speaking time.*

Senator Belmont- *Objection!*

Senator Gao- *Resend*

Senator Belmont- We're using moderated caucus too much. I understand for the previous nominees but if you don't like the structure then you don't like the structure.

***Speak in Pro:*** Senator Belmont, Senator Toro

Senator Gao- *Motion to vote by roll call.*

Senator Toro- I just remembered something. I want to take another look at it.

Senator Gao- *Restate my motion to vote by roll call, accepted.*

**Final Count: 38 - 0 – 1, bill passed.**

Senator Toro-If this structure needed to be amended then what would the process be?

Senate President Hassouneh- If the student body wanted it to be amended then they would take it to the committee on Rules and they would propose an amendment to the Senate.

Senator Wilson: *Motion to use the last vote as final roll call.*

Senate President Hassouneh- We cannot do that. However, I would say that you can take that up with the Rules Chair.
