This doesn't directly answer your question, but I wonder if you are aware of SAA's (Society of American Archivists) Public Library Archives and Special Collections group? Someone may have addressed this question in the PLASC forum (<place at forums.archivists.org>), or you could pose it there and get additional replies. (It isn't necessary to be a member of SAA to participate in the forum). I also have an archival background, but I work in a small public library in a federated system. Based on my experience, what you're currently doing to increase your historical collection's accessibility is light years ahead of what happens in most public libraries. I'm not clear if you have linked or loaded your Toolkit database to the library's catalog. If your library is one of a group that also have their own historical collections, and if the Toolkit database you have created loads reasonably well into the library system's catalog, I think the best thing you could do would be teach your opposite numbers how to use the Toolkit, as it and DACS are generally unknown to most public librarians.

If the Toolkit database is incompatible with the catalog, and if you are applying archival methods to collections (ie. a family donates a deceased genealogist's boxes of notes, video or audio tape, maps, books, and other research material), I would not advocate replacing the Toolkit with PastPerfect software. Although PastPerfect is much more user-friendly than the Toolkit, unless it has changed recently, PastPerfect doesn't have any place to store and display collection finding aids. It's great for keeping track of objects, donors, and funds, and generating fundraising letters, and you can catalog books if you buy an additional component, but it's proprietary, and it doesn't seem to have been designed to deal with unpublished paper.

I applaud your work so far, and I hope all your co-workers know how and are willing to use your database, so that it doesn't become as hidden as the collections when you're not around.

I also work in a Special Collection in a public library and struggle with the best way to organize and catalog the books, manuscript collection, photograph collection, and archives collection. We currently use our opac for most things and add a link in the 856 field to the finding aids. We have most of the manuscripts cataloged in a paper card catalog that is no longer updated. I'm using the standards for ALA's Rare Books and Manuscripts to recatalog them in MARC. Former versions of Past Perfect would actually let you export a MARC record, but the newest version no longer allows that. A local university uses ArchivesSpace and it encodes in EAD.

Our photo collection has a very rough paper index that is a very simple subject cross-reference system. It is no longer updated.

Our digital collections are organized in contentDM. I believe you can import finding aids in it and retain the EAD coding.

We have been trying to keep all the records in one system to avoid patrons having to search several interfaces. Of course, we can't create MARC records for unprocessed collections.

Hi Justin,

We just finished our digitization project with Newspapers.com . Our library's Local History department had about 120 years of newspapers in microfilm format that we wanted to provide better access to. As a small library, we did not have the funds or capabilities to do digitization in-house or with a vendor. I contacted Newspapers.com to see if they would be interested in our papers and they were.

The process took a little less than a year from initial contact to the return of the microfilm. We paid to ship the microfilm to Salt Lake but we did not have to pay for the actual digitization. They benefit by having more newspapers to offer on their site; we benefited in not having to pay for digitization or hosting costs. Digitization took about two months and our microfilm was returned to us in perfect shape. We requested that they insured the microfilm while it was gone from the library and returned, which they agreed to.

Because we supplied the papers, our library gets free access to ONLY our papers (not the whole Newspapers.com site) indefinitely, with no expiration. So far, the increase in patron use has been noticeable and most of that is due to the searchable newspapers. We were also given the option of receiving copies of all of the digitized files, which come in TIFFs, JP2s, PDFs, and XML files. According to the contract we signed, we are allowed to do whatever we want with them (host them on our own website/digital collection, etc.) after three years. We decided to pursue this option so that we still have some control over the files, in case anything happens to Newspapers.com someday! (We didn't want all of this to be for nothing!) The files were about 9 terabytes, so we did have to purchase another hard drive- this was the only other expense required besides shipping the microfilm. They sent their hard drives to us and we are just finishing up with transferring the files to our new storage.

Overall, we had a great experience with this and are contemplating doing it again with other local papers in the future, if Newspapers.com is interested. Please feel free to give me a call or shoot me a personal email (my information is under my signature) if you have more questions or need clarifications.

Don't forget - it isn't as simple as the newspaper deciding to grant/not grant permission - ot if/when a newspaper decided to copyright their newspaper.

"Works" are under copyright at the moment they are created.

There are also items published in the newspaper that were written by employees - and newspapers can give permission but if say a photographer granted the rights to use his photo in a newspaper issue - that does not give the right to anyone else to republish it - which is what would happen if you digitized the newspaper and put it online.

You really want to consult a copyright lawyer.

Someone suggested - just do it and if no one complains then you're OK. While I appreciate the Robin Hood spirit - consider that you are doing this on behalf of your library - and so if digitizing the microfilm is a breech of copyright the library can be at risk for decades into the future - I don't know if there is a statute of limitations on this but why risk the library's meager budget on expensive litigation?

You have multiple layers of copyright.

The copyright of the creators of the content that was published in a newspaper - the writers, photographers etc.

The copyright of the newspaper itself - regardless of whether or not it ever filed for copyright

The copyright of the firm that microfilmed the original newspapers they own the images on the microfilm

The copyright ownership of the digital images - created by the firm that does that work - same as the above

Every step along the way carries copyright liabilities - that's why you so often see digitization projects stop at 1921 - to avoid the liability of sorting that out. Sorting this out takes effort - you want legal advice. All parties need to agree - in writing - after that.
