New Databases

Jerusalem Professionals, Trade and Industry 1921 3,033 listings

This database is derived from a directory of professionals in trade and industry. It gives the address and occupation of those listed. Our thanks to Dr. Motti Friedman for this wonderful resource. (Images available.)

Petah Tikva Census 1922 3,076 listings

This database was built from material from the Oded Yarkoni Archives of the History of Petah Tikva. The information consists of birthplace, age, nationality and some comments. The original was handwritten in Hebrew script. (Images available.)

Members of Synagogues Beit Avraham & Beit Israel, Petah Tikva 1928
52 listings

This database includes members of these two synagogues in Petah Tikva. The information is from the Oded Yarkoni Archives of the History of Petah Tikva. (Images available.)

Voter List ? Knesset Israel Petach Tikva 1936 6,070 listings
13 Settlements 1939 2,795 listings
Givatayim 1944 3,483 listings

Under the British Administration there were elections for Knesset Israel or the Assembly of Representatives. This database is the list of elected parliamentary assembly of the Jewish community in British controlled Palestine. It was established on April 19, 1920 and functioned until February 13, 1949. The lists include those eligible to vote in these elections.

The 1936 Petach Tikva lists include only the name and address. The 1939 Settlements lists include the name, gender, age and locality. The 1944 Givatayim list include the name, birth year and the neighborhood. The lists are from the Central Zionist Archives. (No images available.)

Hashomer Hatzair Kibbutz Census 1940-1 6,689 listings
This database is a census of the Hashomer Hatzair (youth group) from kibbutzim around the country. Each list is slightly different. Some are handwritten while others are typed. Some indicate the birth year and a few have the birth date. All indicate the name of the kibbutz and the name of the member. Some of the kibbutzim have a separate list for the men and women. The lists come from the Yad Ya'ari Archives. (Images available.)

National Kibbutz Youth Organizations 1939-49

This database includes lists from around the country of members of kibbutz youth organizations. Each list is slightly different. The information may include: name, date of record, birth year, birthdate, locality, country of origin, town of origin, date of immigration and education. These lists are from the Yad Ya'ari Archives. (Images available.)

Cattle Growers 2009 1,049 listing

This database includes information such as the name, locality and corporation. The list was found on the Internet. (No images available.)

Updated Databases

Palestine Marriage/Divorce Certificates, 1921-48 4,822 listings

These certificates were issued upon request and are not the same as the ledgers from the Rabanut. Some certificates for marriages were issued 3-20 years after the marriages took place. The information available may include: name, address, age, status, date of record, name of parent, occupation of parent, date of document, etc. These are from the Israel State Archives. (Images available.)

Name Changes 1957 2,061 listings

The lists from which this database of name changes was built were published in Yalkut HaPirsumim (the official publication of the government of Israel). The information is in Hebrew and contains prior surname, prior other names, new surname, new other names, date of record, locality, ID number. The information is located at the David J. Light Law Library, Tel Aviv University. (Images available.)

Births in Zikhron Ya'akov 1883 ? 1920 1,409 listings

This database is a list of children born in Zikhron Ya'akov. The information is from the Mathilde A. Tagger Collection and includes name, birth date, license number and gender. It was prepared from the 'Book of Births' at the Zikhron Ya'akov Historical Archives. (No images available.)

Notrim ? Pre-State Jewish Police Force 485 listings

This database on Notrim, the Pre-State Jewish Police Force may include information such as: name, date, address, rank, regiment and unit. This information is in English. The list comes from the Central Zionist Archives. (No images available.)

I copied and pasted our policy below regarding ?Exhibitions? which includes things in display cases, on the walls, on posters, sitting on top of shelves, etc. But near our local history/Special Collections room we have a standing display case (movable, on legs) which is used by the Cheyenne Genealogical and Historical Society. If the library needs the display case they have first ?crack? at it but this is rare, mostly it?s just the CGHS that uses it. The library has also decided where it would be placed and has moved it around a couple of times. But this exclusive use is unique and as far as I know was accomplished by verbal agreement. The permanent glass display cases in the wall of the library are mostly used for art displays, educational displays, museum quality stuff, etc. at the library?s discretion.

EXHIBITIONS

Exhibitions at Laramie County Library System will support the library?s mission by exhibiting items that contribute to lifelong learning and cultural exposure.

1. LCLS?originated exhibitions have first priority and take precedence over all other exhibitions.
2. Exhibition proposals which are not solicited by the Exhibition Team must be submitted according to the LCLS?s Exhibition Proposal Requirements for review by the library?s Community and Media Relations (CMR) division and Programming Committee. School-age (PreKindergarten-12th Grade) art exhibitions are exempt from this requirement, but must be coordinated through CMR in advance.
3. The Executive Director (County Librarian) has the final decision over all exhibitions.
4. Prices for art available for sale will not be displayed unless an exception is granted by the County Librarian. LCLS will provide artist contact information (with cards provided by the artist) to patrons who ask for such information. If a sale occurs as a result of an exhibition at the library, the artist is requested, though not required, to donate 20% of the proceeds to the Laramie County Library Foundation.
5. Ideas presented in exhibitions at the library do not constitute endorsement by LCLS.

A short answer on the usefulness of the DAR Lineage Books and Patriot Indexes, is a quote from my Library Director: "They make great doorstops."

Here is a longer answer, which might (or might not) help you decide if you want to keep them.

Lineage Books:

Not all of the info was every submitted for verification the DAR staff genealogists. Each person did become a member; however, the lineage books included lineages that were never submitted or vetted by the National Society. As such, they are not considered "canonical" and cannot be used for membership. Just as with any derivative work, careful researchers will use them with a grain of salt. Most, if not all of them, have been digitized either through Google Books or Ancestry.

Patriot Indexes:

>From an historical point of view, the different editions of the Patriot Index will allow users to track minor changes in a patriot's record. However, for many years the changes to the Patriot Index were published in the DAR Newsletter or Magazine. The published changes are often more informative in that they will usually indicate what specifically was changed, (but not with any sources listed). The Millennium Edition (2003) is the last edition. The Patriot Index will not be published again. Instead, the GRS provides researchers with the same information, and much more. Changes to the Patriot or individuals in the lineage can be tracked by using the Descendants Database, which provides a transcription of each verified membership application and/or supplemental applications. The transcriptions are based on what is listed on the application so if new data for dates and places of birth, death or marriage are added, researchers can see these changes by comparing the most recent listings for a patriot with older ones. Changes to the patriot's service and/or residence cannot be tracked through the Descendants Database. Clues to when something might have changed will be found in the list of verified Member Applications (on the Full Record). Look for "CN" next to a National Number. This is an indication that a correction to the patriot's record was made on that paper.

Rhonda:

One option would be to use a hosting service (like Hostmonster, GreenGeeks, etc.) to host your data using a MySQL database. That should have no problem holding the number of records you describe. You would be required to pay a monthly fee for this service: they start out around \$10/month.

This will require you do develop some kind of interface that will allow your users to access the data. PHP is a common choice for this, but it would require your having somebody with knowledge of PHP and SQL available to develop it for you.

Here is one example of something I developed for my Genealogy Society using this approach:

This book contains a portion of the Bible Records from various parts of the United States gathered by an SGS committee. Great care was taken in the transcribing of records. c1970

2. Ancestors from the Eastern Heartland: Pennsylvania, New Jersey, Maryland, and Delaware, compiled by the Middle Atlantic Interest Group, Seattle Genealogical Society, 1990. 289 pp. Genealogy

This publication was designed to facilitate contact between persons with an interest in the same surnames and to provide a source of vital statistics for individuals who lived before 1880 in Pennsylvania, New Jersey, Maryland Delaware.

Surnames are in alphabetical order, with cross references to the main entry. Includes a key to researchers with contact information.

3. Living Pioneers of Washington, by Edmond S. Meany

1995, 240 pp.

These are columns of biographies which appeared in the Seattle Post-Intelligencer newspaper from October 1915 to May 1920.

Edmond S. Meany was a foremost historian, pioneer and personage in Seattle and Washington State. Professor Meany obtained his information by personal interview and also by a form sent to each subject that detailed the information he wanted. Two examples of these forms are included in the back of the book.

4. Seattle Fire Department, 1889

SEATTLE FIRE DEPARTMENT, published by the Seattle Genealogical Society, 1889,

published in 1989 for Washington State's Centennial. 34 pp.

Contains information on Seattle's volunteer and regular firemen, taken from Seattle City Archives. Information on the various engine companies, a brief history of the Seattle Fire Department and a name index.

5. Washington Pioneers from the State of Maine, 1860 ? 1870

In 1860, Washington Territory included all of the land that had been in Oregon Territory, minus what the present-day state of Oregon. In the 1860 and 1870 census records, many of the pioneers from Maine were lumbermen, using the skills they likely used in Maine. Many were young single men. This information was taken from the 1860 and 1870 censuses of Washington Territory.

We just finished doing Newspapers from 1904 - 1913 by scanning originals.

We are now doing a Probate Court Ledger 1852 - 1861 from microfilm.

We take the film and put the film on our ScanPro 3000. We select GreyScale High-Definition (at least 8 Bit) at 600 DPI. When the files are done we use ABBY Pro Ver 12 to open each file and clean them up - i.e. Deskew and clear up the image as best as possible. ABBY then saves our cleaned up digital file and converts to PDF. So we now have three copies - originals,

adjusted originals and PDF's. We also make the files smaller as we go along, in particular the PDF Files. Original files are large.

The Web Site folks can now manipulate the adjusted originals and PDF files to their hearts content. Also having original files can help down the road as technology improves or the Library wishes to do other things with the images. We always can work from original scans.

Am sure there must be easier or better ways to do this kind of work. The above is just the method that seemed to work for us.

We are now doing a Probate Court Ledger 1852 - 1861 from microfilm.

We take the film and put the film on our ScanPro 3000. We select GreyScale High-Definition (at least 8 Bit) at 600 DPI. When the files are done we use ABBY Pro Ver 12 to open each file and clean them up - i.e. Deskew and clear up the image as best as possible. ABBY then saves our cleaned up digital file and converts to PDF. So we now have three copies - originals, adjusted originals and PDF's. We also make the files smaller as we go along, in particular the PDF Files. Original files are large.

The Web Site folks can now manipulate the adjusted originals and PDF files to their hearts content. Also having original files can help down the road as technology improves or the Library wishes to do other things with the images. We always can work from original scans.

Am sure there must be easier or better ways to do this kind of work. The above is just the method that seemed to work for us.

This is a pre-RDA record. We haven't converted our subject/clipping files to RDA, since there are so many. The rest of the library is slowly moving towards that, so we will probably eventually devise a new template for cataloging these files. We use TLC and this is a screenshot in their cataloging utility. Of course, your local fields will be a little different. These are cataloged as Mixed Materials. A few things to note are that we made ourselves the creators of the collection. (New Hanover County Public Library. Special Collections Department.) and then we made an added contributor the name of our collection in the 710 field (North Carolina Subject Archives.) We used LC Subject Headings, but I have seen other collections categorized with Sears. Our subject files have had titles arbitrary attributed over the last fifty years, so there isn't always a lot of rhyme or reason in their bibliographic control. That is why I think the subject headings are very important. There are too many at this point to completely reorder and retitile the actual files.

2. Ancestors from the Eastern Heartland: Pennsylvania, New Jersey, Maryland, and Delaware, compiled by the Middle Atlantic Interest Group, Seattle Genealogical Society, 1990. 289 pp. Genealogy

This publication was designed to facilitate contact between persons with an interest in the same surnames and to provide a source of vital statistics for individuals who lived before 1880 in Pennsylvania, New Jersey, Maryland Delaware.

Surnames are in alphabetical order, with cross references to the main entry. Includes a key to researchers with contact information.

3. Living Pioneers of Washington, by Edmond S. Meany
1995, 240 pp.

These are columns of biographies which appeared in the Seattle Post-Intelligencer newspaper from October 1915 to May 1920.

Edmond S. Meany was a foremost historian, pioneer and personage in Seattle and Washington State. Professor Meany obtained his information by personal interview and also by a form sent to each subject that detailed the information he wanted. Two examples of these forms are included in the back of the book.

This information was taken from the 1860 and 1870 censuses of Washington Territory.
