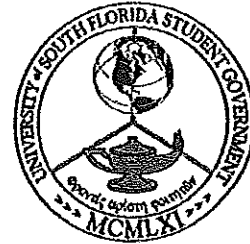

The purpose of this legislation shall be to add the existing position of Assistant Director into Statutes, and update the title of the Director.

A SENATE STATUTORY AMENDMENT

Be it enacted by the Senate of the University of South Florida Student Government assembled, that the following changes be made to the Student Government Statutes:

Chapter

1002

Student Government Advising, Training, and Operations¹

1002.1 The name of this entity shall be Student Government Advising, Training, and Operations Bureau (SGATO), hereinafter referred to as the Bureau.

1002.2 The purpose of the Bureau is to provide advising, training and leadership development to all student officers of Student Government as well as general administrative support.

1002.3 The Bureau shall be comprised of the following:

1002.3.1 The ~~Advisor~~ Director

~~1002.3.1~~1002.3.2 The Assistant Director


~~1002.3.2~~1002.3.3 The Office Manager

~~1002.3.3~~1002.3.4 Graduate Assistant(s)

~~1002.3.4~~1002.3.5 Student Worker(s)


1002.4 The ~~Advisor~~ Director shall consult with the Director of ASMB on financial matters specifically related to Student Government.
