State Banding Permits

The Bird Banding Laboratory utilizes a rather rigorous application procedure before deciding on the permits it grants. Some but not all states require an additional permit. In order that banders and others may know how their state regulations compare with other states, I questioned active banders about their state's permit granting policies. In some cases where I was unable to obtain complete information from banders, I contacted the appropriate state agency. I sought responses from banders not affiliated with a state or feder-

al agency since individuals banding in a professional capacity are often less hampered by state regulation, thus the data apply to those banding as private individuals.

Each potential respondent received a letter explaining the purpose of the survey and a return postcard asking for a brief description of the application process, the fee, and their estimate of degree of difficulty. The first letters to all 50 states were sent in June 1983; follow-up inquiries were completed in April 1984.

Thirty-one states require a permit in addition to the federal permit, and eleven states charge a fee. The degree of difficulty ranges from states which require only a copy of the federal permit to those which require an annual statement of purpose and quarterly or monthly banding reports.

- 4) application notarized,
- 5) annual banding report,

- 6) quarterly banding reports,
- 7) monthly banding reports,
- 8) permit required for raptor banding only,
- 9) permit good for two years,
- 10) state permit valid as long as federal permit current,
- 11) non-resident fee is \$55/yr.
