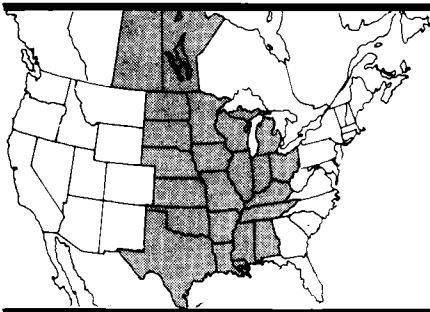

## I.B.B.A. Endowment Fund

At the 1984 meeting of I.B.B.A. we were appointed as a finance committee to develop an endowment fund.

The purpose of such an endowment fund is not to run the everyday finances of I.B.B.A., but to provide an annual interest income so that we can further research on birds, using banding as a tool. Income from the endowment will provide financial support for members who need assistance in purchasing materials or travel in gathering information on a bird species. Grants will be made to individual members of I.B.B.A., not to institutions.

In addition, grants will be given to encourage young people to present their data at the annual meeting and to publish their results with I.B.B.A. Such grants will normally cover the travel expenses to the meeting and subsistence while at the meeting.

The endowment committee will seek funds from I.B.B.A. members and other interested organizations and individuals in the form of cash, securities, real property, or bequests. With gifts of \$2,000 or more, the giver may designate that the funds be used only on a selected species. A gift of \$10,000 will result in the person's name being applied to the award, e.g. "John Jones Song Sparrow Grant".

All real property will be sold on the market unless the donor and finance committee determine that the property should be kept in public ownership.

All the funds will be invested and only the interest income used to support research and travel grants. Investment of funds will be done by the committee in consultation with a professional investment broker to insure maximum safety of all investments. The fund will be audited yearly.

Once a year, a list of donations will be published in the newsletter or other suitable publication of I.B.B.A.

In an emergency, the board of directors may borrow from the income of the endowments to operate the organization if it does not interfere with grants already made, but funds must be repaid within one year.

The success of the endowment fund will depend upon the contributions we can generate. Many businesses will match employee contributions; you may be able to have an equal donation made in your name.

Because we are incorporated in the state of Nebraska, we will be glad to help you with the proper Nebraska format needed to include I.B.B.A. in your will.
