## Comments and an Errata for *Identification Guide to North American Passerines*

I have received many helpful criticisms of and comments about our recently published guide (Pyle, P., Howell, S. N. H., Yunkin, R. P., and DeSante, D. F. 1987. *Identification Guide to North American Passerines*. Slate Creek Press, Bolinas, CA). Many of the comments concern the ornithological content of the guide; these will be synthesized into a second edition which we are planning to publish in three or four years. Most of these initial observations, however, pertain to typographical errors, to unanticipated changes in the figure numbers, and to mistakes made while labeling and laying out the figures during the "one frantic night" we had to do this (see p. ix). The more important of these are listed in the errata below.

At the time we published the guide we were unaware of the Bird Banding Laboratory's (BBL) plans to formulate a standardized list of four-letter codes. Although none of us are going to be completely happy with all of the codes on the recently circulated list (see BBL-MTAB 63 plus addendum), their efforts to produce standardized codes are to be applauded, and I'm sure we will quickly get used to the new set. Therefore, I urge everyone to make the four-letter codes in our guide conform to those of the BBL. A list of changes to make in the guide is given below. I would also like to stress the importance of the "Note to banders" on page 28 of the guide.

I thank Albert E. Conway, Kathy Klimkiewicz, Allan Phillips, Lars Svensson and Kenneth Winkler for extensive comments thus far received, and I will always greatly welcome future comments and criticisms.

### ERRATA

The following corrections should be made in *Identification Guide to North American Passerines*:

**p. 33, table 1:** The wing formulas under Trail's Flycatcher should be "p9–p5 8–13"; and under Least Flycatcher, "p9–p6 < 5.0" should be changed to "p9–p5 ≥ 5.0".

**p. 34:** The labels "HY/SY" and "AHY/ASY" in fig. 26 should be switched.

**p. 37:** In fig. 30, "p9–p5 ≤ 5 mm" should be changed to "p9–p5 > 5 mm".

**p. 46:** Change "GREAT-CRESTED FLYCATCHER" to "GREAT CRESTED FLYCATCHER".

**p. 71:** The specific name for American Crow should be *brachyrhynchus*.

**p. 73:** The specific name for Chihuahuan Raven should be *cryptoleucus*.

**p. 84:** The generic name for Cactus Wren should be *Campylorhynchus*. The band size should be 1A.

**p. 99–100:** Replace all (7) references to "fig. 80" with "fig. 81".

**p. 101:** The generic name for Wrentit should be *Chamaea*.

**p. 107 (and p. 272):** The specific name of Crissal Thrasher should be changed to *crissale* in accordance with the 35th supplement to the American Ornithologists' Union Check-list (A.O.U. 1985. Auk 102:680–686).

**p. 108:** The specific name for Le Conte's Thrasher should be *lecontei*.

## Errata (cont.)

**p. 110:** The reference to "fig. 94" under Species should be changed to "fig. 93".

**p. 111:** The reference to "fig. 97" under Sex should be changed to "fig. 96".

**p. 115:** The measurements for culmen in Fig. 99 should be switched

**p. 120:** The band size for Black-capped Vireo should be changed to 0.

**p. 125:** Yellow-green Vireo should be considered a separate species, *Vireo flavoviridis* in accordance with the 36th supplement to the A.O.U. check-list (A.O.U. 1987. Auk 104:591–596).

**p. 144:** The reference (2) to "fig. 123" under Subspecies should be changed to "fig. 124".

**p. 144:** The labels "Myrtle" and "Audubon's" in Fig. 122 should be switched.

**p. 165:** The generic name for Black-and-white Warbler should be *Mniotilta*.

**p. 167:** The specific name for Prothonotary Warbler should be *citrea*.

**p. 171–175:** References to "fig. 147" (4) in the text should be changed to "fig. 148" and references to "fig. 148" (28) should be changed to "fig. 147".

**p. 180:** Add labels to fig 154; "AHY/ASY" to left-hand illustration, "HY/SY" to right-hand illustration.

**p. 209:** The species number for Five-striped Sparrow should be 574.2.

**p. 216:** The specific name for White-throated Sparrow should be *albicollis*.

**p. 217:** The specific name for Golden-crowned Sparrow should be *atricapilla*.

**p. 221:** The specific name for Yellow-eyed Junco should be *phaeonorus*.

**p. 238:** The specific name for Bronzed Cowbird should be *aeneus*.

**p. 248:** The reference to "fig. 212" under House Finch, Age/Sex should be changed to "fig. 213".

**p. 250:** The reference to "fig. 215" under Common Redpoll, Species should be changed to "fig. 216".

**p. 250–255:** All references (14) in the text to "fig. 216" should be changed to "fig. 215".

**p. 251:** The head illustrations in figs. 216 and 217 should be switched and the references in the captions to "upptail covert" should be changed to "undertail covert".

**p. 268:** Insert Willoughby, E. J. 1986. An unusual sequence of molts and plumages in Cassin's and Bachman's sparrows. Condor 88(4): 461–472.
