*The Student Government Programming Council's duties fall under the Programming Cabinet. The council's work is unnecessary. This change matches statutes to standard practice.*

### A SENATE STATUTORY AMENDMENT

Be it enacted by the Senate of the University of South Florida Student Government assembled, that the following changes be made to the Student Government Statutes:

#### Student Government Programming Council<sup>1</sup>

~~The purpose of the Student Government Programming Council (SG Programming Council) shall be to have representation of all Student Government entities in the programming of SG-wide events:~~

~~The SG Programming Council shall be comprised of:~~

~~At least 2 members of the Executive Branch appointed by the Student Body President  
At least 2 members of the Legislative Branch appointed by the Senate President  
2 members of the Judicial Branch appointed by the Chief Justice  
Student Government Advising, Training and Operations Director or his or her designee. (ex officio, non-voting)~~

~~The formation of the Programming Council shall be determined by a majority vote of JuSenEx no earlier than the approval of the Executive Branch Structure and no later than the last Friday in June.<sup>2</sup>~~

<sup>2</sup>SB [S] 54-021 adds this clause to clarify when the Programming Council will be formed

~~All appointments shall be made by the close of business on the last Friday of the month of June to the Director of SGATO the next business day after the SG Programming Council has been formed.~~

~~The Director of SGATO shall call the first meeting of the SG Programming Council to order within five (5) business days of formation for the purposes of electing a Chair and a Vice-Chair.~~

~~The SG Programming Council may also assign or elect Project Team Leaders for particular events at the discretion of the committee.~~

~~The SG Programming Council shall plan and organize the following SG-wide events:~~

~~Student Government Inauguration~~

~~The SG Fall and Spring Social~~

~~The SG Holiday Party~~

~~The SG End of the Year Banquet~~

~~Any collaborative and/or team event~~

~~Any Intramural SG Teams registered with Campus Recreation~~
