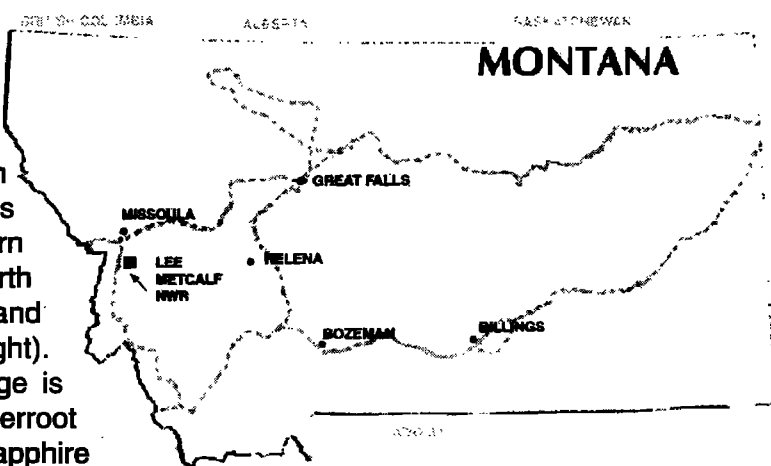

## 2003 ANNUAL MEETING in MONTANA

The Lee Metcalf National Wildlife Refuge, U.S. Fish and Wildlife Service, will host the 2003 Western Bird Banding Association Annual Meeting, 28-31 Aug. The refuge is located in the Bitterroot Valley of western Montana, 25 mi south of Missoula, just north of the town of Stevensville, on the Lewis and Clark Trail (wiggly line on map at right). Established in 1964, the 2800-acre refuge is situated in a river-bottom with the Bitterroot Mountains to the West, and the Sapphire Mountains to the east. The Bitterroot River borders the Refuge to the west, while 13 man-made impoundments provide resting, feeding, and nesting habitat for a variety of migratory birds. Ten years of MAPS banding data have been collected from the Refuge's riparian habitat along the Bitterroot River. This refuge provides a unique experience for conference attendees with its proximity to Missoula International Airport (approximately 30 miles), Teller Wildlife Refuge for gourmet catering and lodging, and the Refuge's prolific banding station, which will enable hands-on mist-netting and banding opportunities. Several places are available for field trips, including the National Bison Range Complex, Bitterroot National Forest, and several other local birding hot spots.

Lodging will be at Teller Wildlife Refuge, a private, non-profit refuge in Corvallis, MT, approximately ten miles south of the NWR. Teller provides an Oct.-Dec. 2002



exceptional experience for its guests, including lodging in historic 1800s farm houses, fully catered gourmet meals and a beautiful, farm-like atmosphere. Although Teller can accommodate only 22 overnight guests in shared rooms, they have arranged for the over-flow to stay at the Holiday Inn Express in Hamilton, another ten miles south. Teller will provide three meals a day for all the attendees, and can provide boxed breakfasts and lunches as needed. One large conference room and several small conference rooms are available for our use. Below is a breakdown of the rates Teller will charge for the conference:

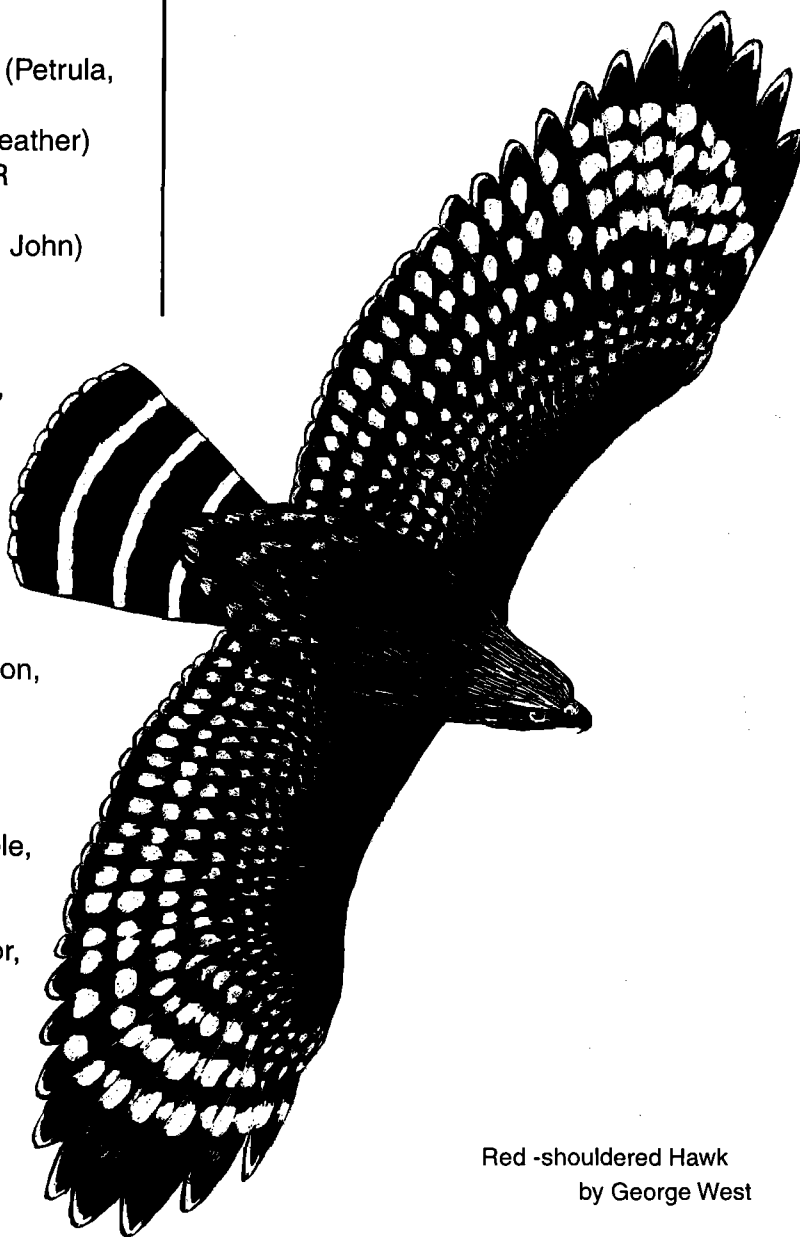
