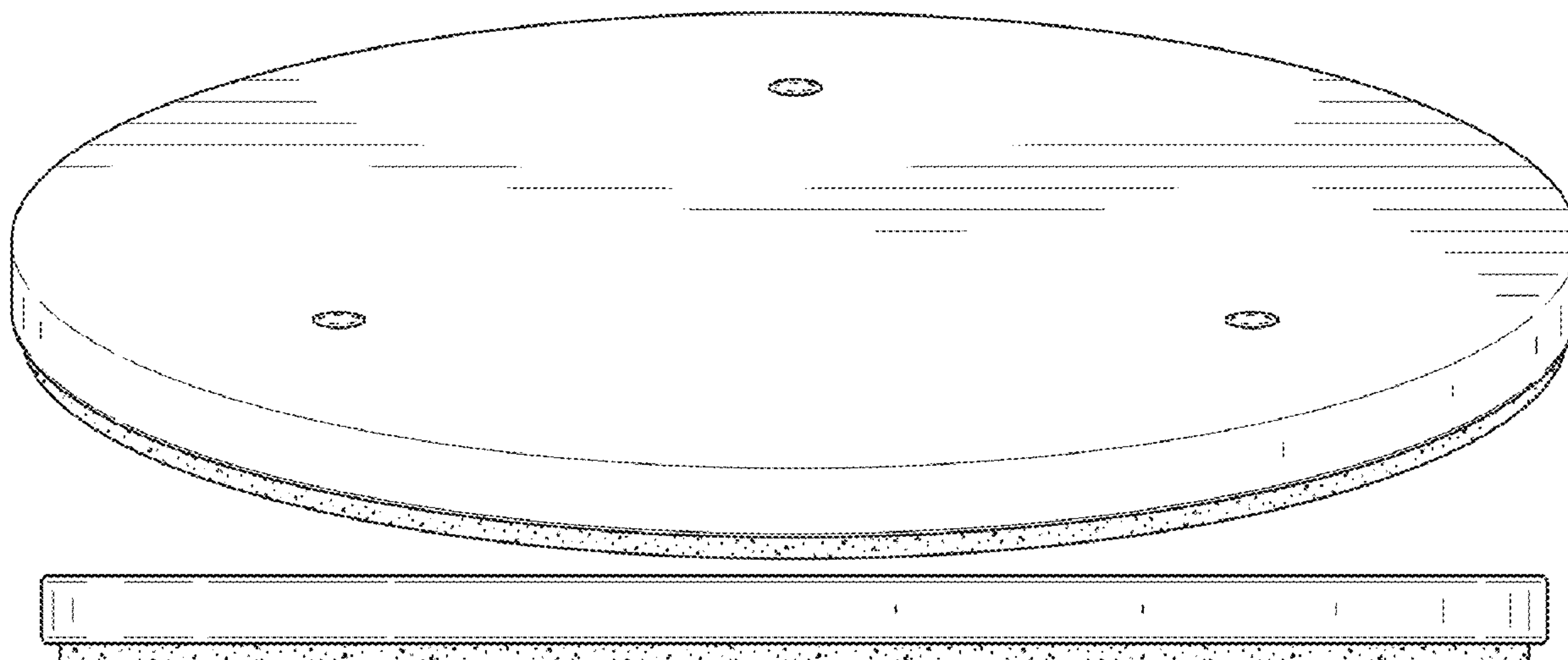
FIG. 1 is a perspective view of a base plate for a foot pedal showing my new design.

The broken lines in FIGS. 1 and 6 depict portions of the base plate for a foot pedal that form no part of the claimed design. The foot pedal rendered in short broken lines in FIG. 8 illustrates environmental subject matter intended to assist in showing how the design appears when in use and forms no part of the claim.
The stippling shown in the drawings illustrates a non-skid surface.

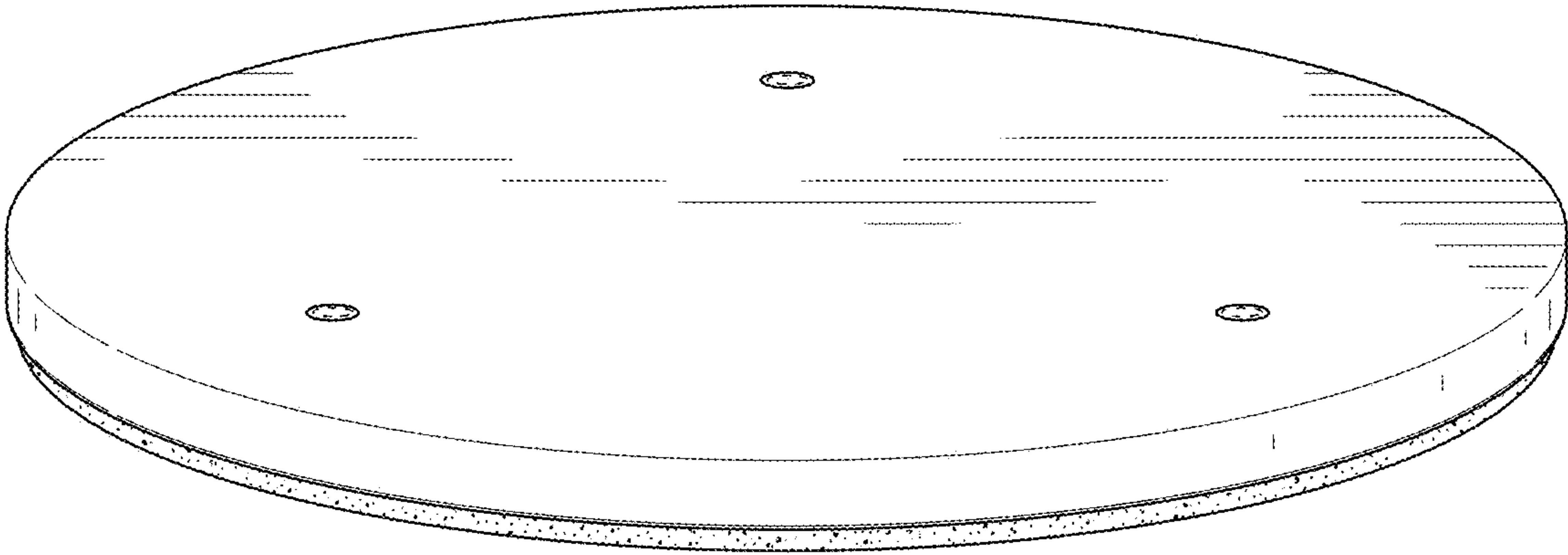

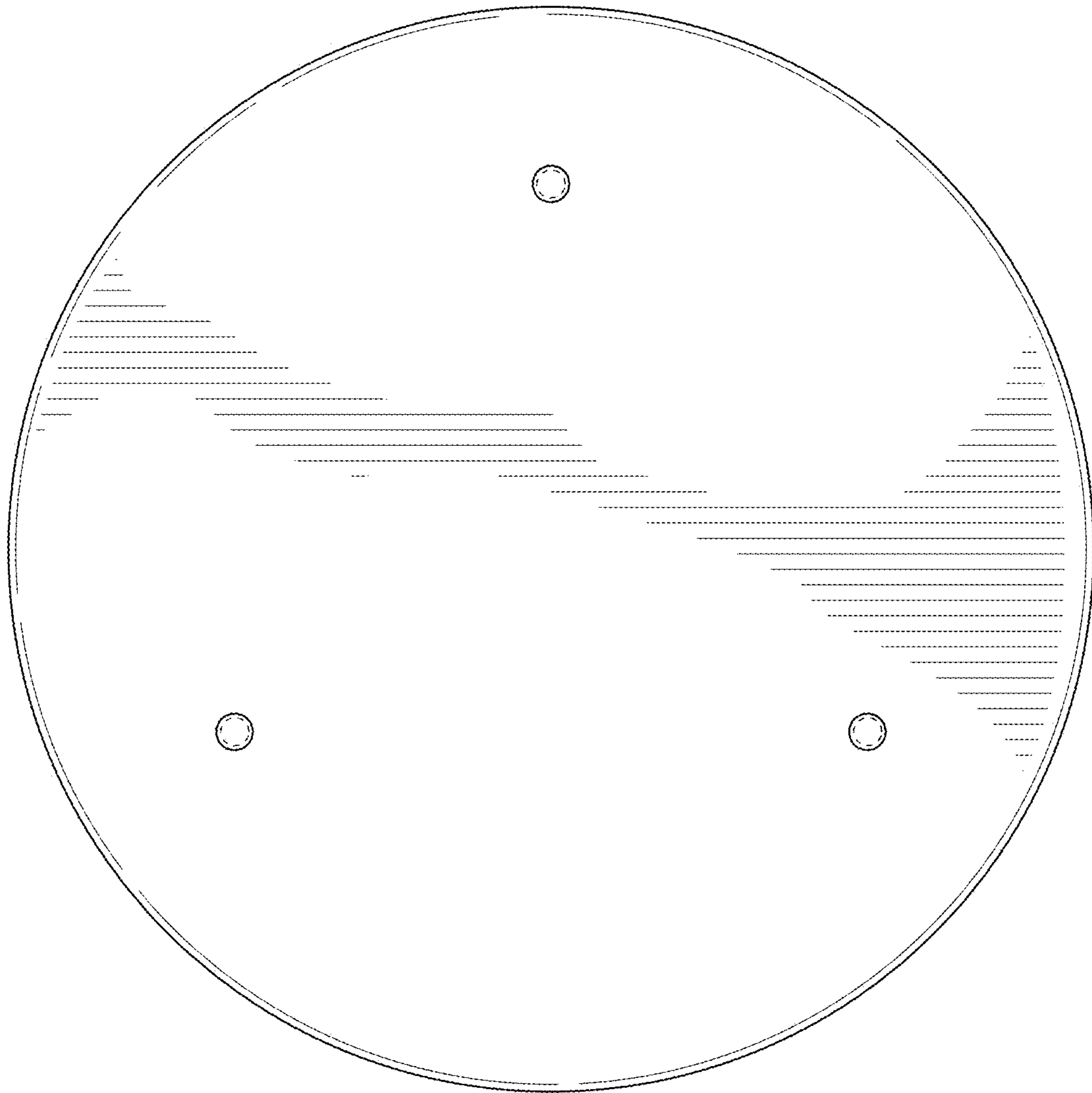

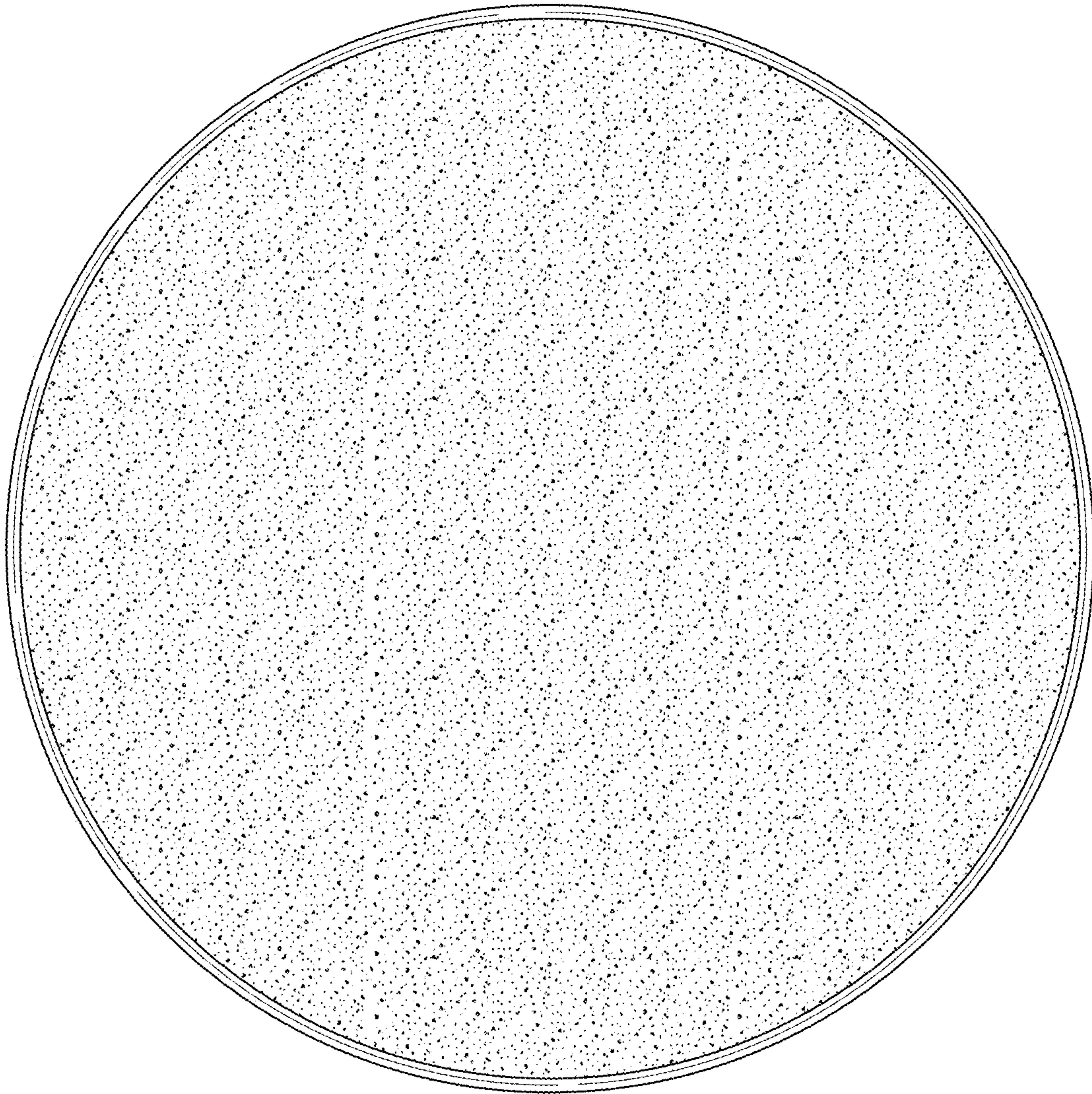

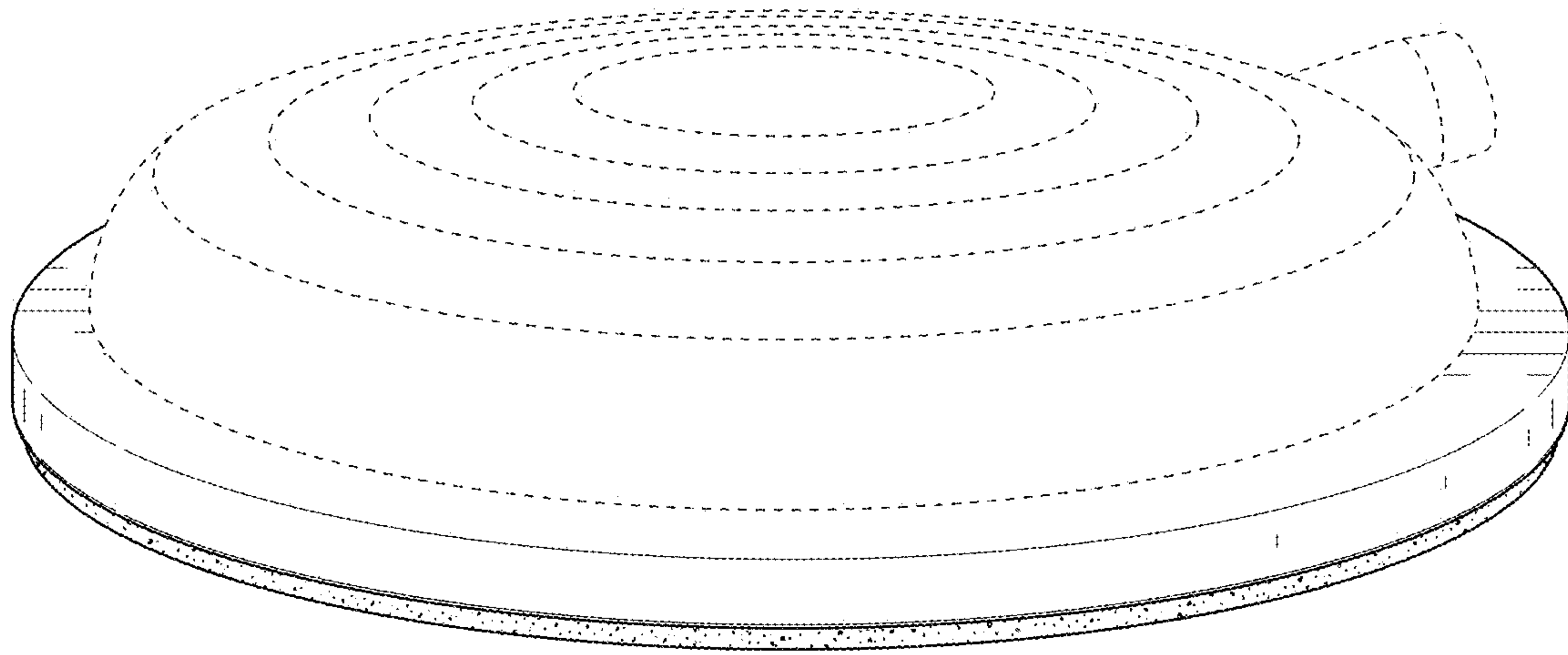
