

# KEYNOTE SPEAKER



## The Honorable Judge E. J. Salcines DISTRICT COURT OF APPEAL

District Court of Appeal Judge E. J. Salcines has been a member of the Florida Bar for the last 50 years. A career federal and state prosecuting attorney for 22 years, he was the elected State (Prosecuting) Attorney in Tampa for 16 years. For 10 years, he served on the State Medical Examiners Commission. He has served on Florida's Second District Court of Appeal since 1998 and is now retired.

Besides his BA and JD degrees, he has two Honorary Doctorate degrees. For 35 years, he taught trial advocacy in the summer Short Courses at Northwestern University College of Law. He was President of the Florida Prosecuting Attorneys Association, Vice-President of the National District Attorneys Association and Treasurer of the American Academy of Forensic Sciences Foundation.



The E. J. Salcines Student Lounge at South Texas College of Law was named in his honor. He was knighted by King Juan Carlos of Spain and received the 2008 Good Government Award from Hillsborough County who annually awards the E. J. Salcines Lifetime Leadership Award. He received the “Champion of Justice Award” from the Tampa Bay Trial Lawyers Association. In 2010 the Florida Legislature in a public ceremony in the Senate Chambers commended the Honorable E.J. Salcines of Tampa recognizing his almost half a century of community activity, public service and commitment to the administration of justice. In June 2013, he was the keynote speaker at the Florida Bar Association Convention luncheon honoring the judges and lawyers who have been members of the Florida Bar for 50 years or more. In 2014, the Florida Prosecuting Attorneys Association presented E.J. Salcines with their Lifetime Achievement Award for half a century of dedicated public service in the administration of justice.

Judge Salcines is a recognized authority on the history of Florida. He is a frequent speaker at state and local historical society conferences and conventions. He is a founding member and Trustee of the Tampa Bay History Center and former vice president of the Tampa Historical Society. He is currently on the Mayor’s Riverwalk Historical Marker Committee. He was president of the West Tampa Centennial Society and Chairman of Tampa’s award-winning activities celebrating the 500th Anniversary of Christopher Columbus’ discovery of America that brought the replicas of Columbus’ three ships to Tampa Bay. He has been a leader in commemorating the 500th anniversary of Juan Ponce de Leon’s arrival in Florida – the first documented arrival of European’s in the continental United States and Canada. In 2012, he was the tour guide of a delegation from the Tampa Bay History Center to northern Spain. He currently is the U. S. representative on the Board of Trustees of the Museum of Immigration in Spain.
